ORDINANCE NO. 158219

An ordinance amending Section 63.44 and Section 85.02 of the Los Angeles Municipal Code to regulate the parking of vehicles in public parking lots.

THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:

Section 1. Subsection L of Section 63.44 of the Los Angeles Municipal Code is hereby redesignated Subsection N and relocated in this Section in alphabetical sequence accordingly.

Sec. 2. Section 63.44 of the Los Angeles Municipal Code is hereby amended by adding a new Subsection L thereto, said Subsection to read:

L. Notwithstanding the provisions of Section 63.44 K 2, where a parking lot is located within any park consisting of beach and water recreation area, the Director of Beaches, or the Board in the event the City exercises management and control over such park, may post a sign at the entrance to such parking lot indicating that the lot is closed to public parking at an hour earlier than 1:00 a.m. or later than 3:00 a.m. When such sign is posted, no person shall stand or park

1 an occupied or unoccupied vehicle within the parking lot  
2 during the hours wherein parking is prohibited. Any  
3 vehicle parked in violation of the provisions of this  
4 Subsection may be removed from such parking lot in  
5 accordance with the provisions of the Vehicle Code of  
6 the State of California.

8 Sec. 3. Section 85.02 of the Los Angeles Municipal  
9 Code is amended to read:

10 SEC. 85.02. USE OF STREETS AND PUBLIC PARKING LOTS FOR  
11 HABITATION:

12 No person shall use a vehicle parked or standing  
13 upon any City street, or upon any parking lot owned by  
14 the City of Los Angeles and under control of the City of  
15 Los Angeles or under control of the Los Angeles County  
16 Department of Beaches and Harbors, as living quarters,  
17 either overnight, day-by-day, or otherwise.
