An Ordinance amending the Los Angeles Municipal Code.

THE PEOPLE OF THE CITY OF LOS ANGELES

DO ORDAIN AS FOLLOWS:

Section 1. Section. 41.27 of the Los Angeles Municipal Code is hereby amended by adding a Subsection (d) to read as follows:

(d) No person who has in his or her possession any bottle, can or other receptacle containing any alcoholic beverage which has been opened, or a seal broken, or the contents of which have been partially removed, shall enter, be, or remain on the posted premises of, including the posted parking lot immediately adjacent to, any retail package off-sale alcoholic beverage licensee licensed pursuant to Division 9 (commencing with Section 23000) of the Business and Professions Code of the State of California, or on any public sidewalk immediately adjacent to the licensed and posted premises. Any person violating any provision of this Subsection shall be guilty of an infraction.

Section 2. Section 41.27 of the Los Angeles Municipal Code is hereby amended by adding a Subsection (e) to read as follows:

1 (e) All retail package off-sale alcoholic beverage
2 licensees licensed pursuant to Division 9 (commencing with Section
3 23000) of the Business and Professions Code of the State of
4 California shall install and maintain signs on the licensed
5 premises, clearly visible to the patrons of the licensee and to
6 persons in or on any parking lot or public sidewalk immediately
7 adjacent to the licensed premises, which notify all such persons
8 that the provisions of Subsection (d) of this Section are
9 applicable. Any licensee violating any provision of this
10 Subsection shall be guilty of an infraction.

12 Section 3. Section 41.27 of the Los Angeles Municipal
13 Code is hereby amended by adding a Subsection (f) to read as
14 follows:

16 (f) As used in Subsections (d) and (g) of this Section,
17 "posted premises" means those premises which are subject to
18 licensure under any retail package off-sale alcoholic beverage
19 license, the parking lot immediately adjacent to the licensed
20 premises, and any public sidewalk immediately adjacent to the
21 licensed premises on which clearly visible notices have placed
22 pursuant to the provisions of Subsection (e) of this Section.

24 Section 4. Section 41.27 of the Los Angeles Municipal
25 Code is hereby amended by adding a Subsection (g) to read as
26 follows:

1 (g) The provisions of Subsections (d) and (e) of this
2 Section shall not apply to a private residential parking lot which
3 is immediately adjacent to the posted premises.

5 Section 5. Section 41.27 of the Los Angeles Municipal
6 Code is hereby amended by adding a Subsection (h) to read as
7 follows:

9 (h) No person shall have in his or her possession any
10 bottle, can or other receptacle containing any alcoholic beverage
11 which has been opened, or a seal broken, or the contents of which
12 have been partially removed, upon any street, sidewalk or parkway,
13 park, playground, Los Angeles Memorial Coliseum, or in any railroad
14 depot or bus station, or in any public place, or in any place open
15 to the patronage of the public, which premises are not licensed for
16 the consumption of such alcoholic beverage on the premises. Any
17 person violating any provision of this Subsection shall be guilty
18 of an infraction.
