

ORDINANCE NO. 164845

3 An ordinance amending Sections 12.20.3, 12.24, 12.27,  
4 12.28, 12.32, 13.00, 17.06, 17.14 and 17.59 of the Los Angeles  
5 Municipal Code to require posting of hearing notices on the  
6 site of the property involved.

8 THE PEOPLE OF THE CITY OF LOS ANGELES

9 DO ORDAIN AS FOLLOWS:

10  
11 Section 1. Subdivision 5 of Subsection F of Section  
12 12.20.3 of the Los Angeles Municipal Code is hereby amended by  
13 adding an unnumbered paragraph to read as follows:

14 Notice of the public hearing shall be posted, by  
15 the applicant, in a conspicuous place on the property  
16 involved at least five days prior to the date of the  
17 public hearing. The applicant, in addition to  
18 posting notice of the public hearing, shall also post  
19 notice of the initial Commission meeting on the  
20 matter. This notice shall be posted in a conspicuous  
21 place on the property involved at least five days  
22 prior to the date of the meeting.

23  
24 Sec. 2. Paragraph (b) of Subdivision 3 of Subsection  
25 B of Section 12.24 of the Los Angeles Municipal Code is hereby  
26 amended by adding a Subparagraph 3 to read as follows:

1           (3) By the applicant posting notice of the  
2 public hearing in a conspicuous place on the property  
3 involved at least ten days prior to the date of the  
4 public hearing. If a hearing examiner is designated  
5 to conduct the public hearing then the applicant, in  
6 addition to posting notice of the public hearing,  
7 shall also post notice of the initial Commission  
8 meeting on the matter. This notice shall be posted  
9 in a conspicuous place on the property involved at  
10 least ten days prior to the date of the meeting.

11  
12           Sec. 3. The last unnumbered paragraph of Paragraph  
13 (b) of Subdivision 3 of Subsection B of Section 12.27 of the  
14 Los Angeles Municipal Code is hereby amended by adding the  
15 following sentence:

16           When a public hearing is scheduled pursuant to  
17 this Section, notice of such public hearing shall be  
18 posted, by the applicant, in a conspicuous place on  
19 the property involved at least ten days prior to the  
20 date of the public hearing.

21  
22           Sec. 4. Subdivision 5 of Subsection A of Section  
23 12.28 of the Los Angeles Municipal Code is hereby amended by  
24 adding a new fourth unnumbered paragraph to read:

25           In addition, notice of such public hearing shall  
26 be posted, by the applicant, in a conspicuous place  
27 on the property involved at least ten days prior to  
28 the date of the public hearing.

1           Sec. 5. Subdivision 1 of Subsection C of Section  
2 12.32 of the Los Angeles Municipal Code is hereby amended by  
3 adding a new Paragraph (d) to read:

4           (d) By the applicant posting notice of the  
5 public hearing in a conspicuous place on the property  
6 involved at least ten days prior to the date of the  
7 public hearing. If a hearing examiner is designated  
8 to conduct the public hearing then the applicant, in  
9 addition to posting notice of the public hearing,  
10 shall also post notice of the initial Commission  
11 meeting on the matter. This notice shall be posted  
12 in a conspicuous place on the property involved at  
13 least ten days prior to the date of the meeting.

14  
15           Sec. 6. A new Paragraph (c) is hereby added  
16 immediately following Paragraph (b) of Subdivision 3 of  
17 Subsection C of Section 13.00 of the Los Angeles Municipal  
18 Code, to read as follows:

19           (c) By the applicant posting notice of the  
20 hearing in a conspicuous place on the property  
21 involved at least ten days prior to the date of the  
22 hearing. If a hearing examiner is designated to  
23 conduct the public hearing then the applicant, in  
24 addition to posting notice of the public hearing,  
25 shall also post notice of the initial Commission  
26 meeting on the matter. This notice shall be posted

1 in a conspicuous place on the property involved at  
2 least ten days prior to the date of the meeting.

3  
4 Sec. 7. Subdivision 1 of Subsection A of Section  
5 17.06 of the Los Angeles Municipal Code is hereby amended by  
6 adding an unnumbered paragraph to read as follows:

7 Notice of the public hearing shall be posted, by  
8 the applicant, in a conspicuous place on the property  
9 involved at least ten days prior to the date of the  
10 public hearing.

11  
12 Sec. 8. Subsection B of Section 17.14 of the  
13 Los Angeles Municipal Code is hereby amended by adding an  
14 unnumbered paragraph to read:

15 Notice of the public hearing shall be posted, by  
16 the applicant, in a conspicuous place on the property  
17 involved at least ten days prior to the date of the  
18 public hearing.

19  
20 Sec. 9. Subsection B of Section 17.59 of the  
21 Los Angeles Municipal Code is hereby amended by adding a  
22 second unnumbered paragraph to read:

23 Notice of the public hearing shall be posted, by  
24 the applicant, in a conspicuous place on the property  
25 involved at least ten days prior to the date of the  
26 public hearing.

Sec. 12. The City Clerk shall certify to the passage of this ordinance and cause the same to be published in some daily newspaper printed and published in the City of Los Angeles.
