Notice of the public hearing shall be posted, by the applicant, in a conspicuous place on the property involved at least five days prior to the date of the public hearing. The applicant, in addition to posting notice of the public hearing, shall also post notice of the initial Commission meeting on the matter. This notice shall be posted in a conspicuous place on the property involved at least five days prior to the date of the meeting.

Sec. 2. Paragraph (b) of Subdivision 3 of Subsection
B of Section 12.24 of the Los Angeles Municipal. Code is hereby
amended by adding a Subparagraph 3 to read as follows:

(3) By the applicant posting notice of the public hearing in a conspicuous place on the property involved at least ten days prior to the date of the public hearing. If a hearing examiner is designated to conduct the public hearing then the applicant, in addition to posting notice of the public hearing, shall also post notice of the initial Commission meeting on the matter.
