

ORDINANCE NO. 175366

An ordinance amending Section 62.03 of the Los Angeles Municipal Code to require new Above Ground Facilities Installations be placed underground in areas where existing AGFs are required to be underground.

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**

Section 1. A new Paragraph 8 is added to Part II, General Restriction, of Section 62.03.2 to read:

**8.** Areas that have been designated by the Board of Public Works, upon the recommendation of the City Council, as "underground AGF areas." The Board of Public Works may make this designation only in areas where all existing AGFs, as defined in Parts I and IX C, are currently underground or are required to be installed underground by law or contract.

Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located in the Main Street lobby to the City Hall; one copy on the bulletin board located at the ground level at the Los Angeles Street entrance to the Los Angeles Police Department; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.

DECLARATION OF POSTING ORDINANCE
