

ORDINANCE NO. 173304

A Charter implementation ordinance amending Los Angeles Municipal Code Sections 21.00 through 29.02 to make technical corrections to references in order to be consistent with the Charter adopted by the voters at the general municipal election held June 8, 1999.

THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:

Section 1. Each reference in Sections 21.00 through 29.02, inclusive, of the Los Angeles Municipal Code to "City Clerk" is amended to read "Director of Finance". However, until such time as the Mayor and Council shall establish as the official date of transfer of responsibilities, personnel and other resources required to perform the functions involved with Los Angeles Municipal Code Chapter II - Licenses, Permits, Business Regulations, from the Office of the City Clerk to the Office of Finance, the City Clerk shall continue to perform the functions with respect to the responsibilities under Chapter II.

Sec. 2. Section 21.14.5(a) and Section 21.16.5(a) of the Los Angeles Municipal Code are each amended to delete the reference to "Charter Section 380" and to replace it with "Charter Section 302".

Sec. 3. Section 21.16.5(c) of the Los Angeles Municipal Code is amended to delete the reference to "Charter Section 355" and to replace it with "Charter Section 343".

Sec. 4. Sections 21.26(m), 21.16.5(c), and 28.04(c)(3) of the Los Angeles Municipal Code are amended to delete the references to "City Administrative Officer" and to replace them with references to the "Director of the Office of Administrative and Research Services".

Sec. 5. Sections 21.14.3(b) and 21.16.3(b) of the Los Angeles Municipal Code are amended to delete the references to "Subdivision (d) of Subsection (11) of Section 2 of Article I" and to replace them with references to "Section 101".

Sec. 6. Section 22.12(c) and Section 22.13(e) of the Los Angeles Municipal Code are each amended to delete the reference to "Charter Section 355(3)" and to replace it with "Charter Section 343(c)".

Sec. 7. Section 22.13(b) of the Los Angeles Municipal Code is amended to delete the reference to "Charter Section 363 and 376" and to replace it with "Charter Section 350".

Sec. 8. The provisions of this ordinance shall be operative on July 1, 2000.


Sec. 9. The City Clerk shall certify to the passage of this ordinance and cause it to be published in a daily newspaper printed and published in the City of Los Angeles.
