2. Section ~~44~~^{281(b)}(Z) of the City Charter provides that the City Clerk shall have custody of, preserve and be responsible for this document when not in actual use by other officers. In compliance with this provision, RETURN FORTHWITH TO THE CITY CLERK WHEN NOT IN ACTUAL USE.

3. In this connection, the Government Code of California provides:

"Sec. 6200. Every officer having the custody of any record, map, or book, or of any paper or proceeding of any court, filed or deposited in any public office, or placed in his hands for any purpose, who is guilty of stealing, wilfully destroying, mutilating, defacing, altering or falsifying, removing or secreting the whole or any part of such record, map, book, paper, or proceeding, or who permits any other person so to do, is punishable by imprisonment in the State prison for two, three, or four years."

"Sec. 6201. Every person not an officer referred to in Section 6200, who is guilty of any of the acts specified in that section, is punishable by imprisonment in the State prison or in a county jail not exceeding one year, or by a fine not exceeding one thousand dollars (\$1000), or by both such fine and imprisonment."

4. Review City Documents in your possession EVERY 30 DAYS. Request time extensions only when absolutely necessary.

5. NOTIFY THE CITY CLERK (Index Division - Ext. 5703) if this document is transmitted to any other Department of Office, and release your responsibility.

6. RETURN DOCUMENTS NOT IN ACTUAL USE TO THE CITY CLERK IMMEDIATELY.
