

## ORDINANCE NO. 175641

An ordinance amending Ordinance No. 173872, the Porter Ranch Land Use/Transportation Specific Plan.

## THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. Paragraph (c) of Subdivision 2 of Subsection A of Section 7 of Ordinance No. 173872, the Porter Ranch Land Use/Transportation Specific Plan, is amended to read:

(c) Subareas C, E, F: Every lot in Subareas C and F shall have a minimum width of 50 feet and a minimum lot area of 5,500 square feet. Every lot in Subarea E shall have a minimum width of 65 feet and a minimum lot area of 7,150 square feet.

Sec. 2. Paragraphs (c), (f), (g) and (h) of Subdivision 1 of Subsection B of Section 7 of Ordinance No. 173872, the Porter Ranch Land Use/Transportation Specific Plan, are amended to read:

(c) Subarea C: The density in Subarea C shall not exceed a total of 270 dwelling units;

(f) Subarea F: The density in Subarea F shall not exceed a total of 160 dwelling units;

(g) Subareas G-1 and G-2: The density in Subareas G-1 and G-2, combined, shall not exceed a total of 658 dwelling units; and

(h) Subarea H: The density in Subarea H shall not exceed a total of 62 dwelling units.

Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located in the Main Street lobby to the City Hall; one copy on the bulletin board located at the ground level at the Los Angeles Street entrance to the Los Angeles Police Department; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
