TRANSPORTATION COMMITTEE REPORT relative to amending the Los Angeles Municipal Code (LAMC) to provide for free parking for certain alternative fuel vehicles.

Recommendations for Council action:

- 1. RECEIVE and FILE the draft Ordinance amending Sections 88.00, 88.07, 88.13, 88.57, and 88.63 of the LAMC to provide for free parking of certain alternative fuel vehicles at parking meters managed by the Los Angeles Department of Transportation (LADOT) through January 1, 2011.
- 2. TERMINATE the pilot program effective March 1, 2009.
- 3. INSTRUCT the LADOT to perform outreach to Neighborhood Councils and effected constituency.

#### <u>SUMMARY</u>

In a report dated January 16, 2008, the City Attorney forwarded a draft Ordinance to amend Sections 88.00, 88.07, 88.13, 88.57, and 88.63 of the LAMC to provide for free parking of certain alternative fuel vehicles at parking meters managed by the LADOT through January 1, 2011. The City Attorney also noted that the draft Ordinance also provides for an exemption from the requirement to deposit coins at City parking meters controlled by the LADOT.

At a special meeting held on January 28, 2009, the Transportation Committee considered the City Attorney report dated January 16, 2008 regarding a draft Ordinance to amend Sections 88.00, 88.07, 88.13, 88.57, and 88.63 of the LAMC to provide for free parking of certain alternative fuel vehicles at parking meters managed by the LADOT through January 1, 2011. A representative from the LADOT provided background information on the matter. An opportunity for public comment was held. Afterwards, the Committee moved to receive and file the draft Ordinance, terminate the pilot program, and instruct the LADOT to perform outreach to Neighborhood Councils and effected constituency. This matter is now forwarded to the Council for its consideration.

An ordinance amending Sections 88.00, 88.07, 88.13, 88.57 and 88.63 of Chapter VIII of the Los Angeles Municipal Code to establish a \$0.00 hourly rate and to provide an exemption from the requirement to deposit coins for those vehicles displaying Clean Air Vehicle Decals issued by the California Department of Motor Vehicles when parked at Department of Transportation controlled on- and off-street parking meters in the City of Los Angeles.

## THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. The first paragraph of Section 88.00 of Division U of Chapter VIII of the Los Angeles Municipal Code is amended to read:

## SEC. 88.00. PARKING METER ZONES AND RATES ESTABLISHED.

The following parking meter zones and hourly rates are hereby established. Notwithstanding the hourly rates specified in this section for each Parking Meter Zone, the rate in every Parking Meter Zone for vehicles displaying Clean Air Vehicle Decals issued by the California Department of Motor Vehicles pursuant to California Vehicle Code Section 5205.5 shall be \$0.00 per hour. Payment of the rates established in this section shall be in accordance with the appropriate schedules established by the Board.

Sec. 2. Section 88.07 of Division U of Chapter VIII of the Los Angeles Municipal Code is amended by adding the following sentence at the end of the section to read:

The provisions of this section shall not apply to vehicles displaying Clean Air Vehicle Decals issued by the California Department of Motor Vehicles pursuant to California Vehicle Code Section 5205.5.

Sec. 3. Subsection (b) of Section 88.13 of Division U of Chapter VIII of the Los Angeles Municipal Code is amended to read:

(b) It shall be unlawful for any person to cause, allow, permit or suffer any vehicle to remain in any parking meter space for more than the time indicated by proper signs placed on the parking meter indicating the maximum parking time allowed in the parking meter space, or during any time the parking meter is indicating that the time has elapsed for which coins of the United States of America have been deposited in the parking meter, provided, however, that the provisions of this section shall not apply to any vehicle described in Section 80.05, vehicles owned by the City of Los Angeles, vehicles displaying Clean Air Vehicle Decals issued by the California Department of Motor Vehicles pursuant to California Vehicle Code Section 5205.5 or vehicles operated pursuant to Sections 88.01.1, 88.03.1 and 88.06.1.

Sec. 4. Section 88.57 of Division U of Chapter VIII of the Los Angeles Municipal Code is amended by adding the following sentence at the end of the section tor ead:

The provisions of this section shall not apply to vehicles displaying Clean Air Vehicle Decals issued by the California Department of Motor Vehicles pursuant to California Vehicle Code Section 5205.5.

Sec. 5. Subsection (b) of Section 88.63 of Division U of Chapter VIII of the Los Angeles Municipal Code is amended to read:

(b) It shall be unlawful for any person to cause, allow, permit or suffer any vehicle to remain in any off-street parking meter space for more than the time indicated by proper signs placed on the off-street parking meter indicating the maximum parking time allowed in the off-street parking meter space, or during any time the off-street parking meter is indicating that the time has elapsed for which coins of the United States of America have been deposited in the off-street parking meter; provided, however, that the provisions of this section shall not apply to any vehicle described in Section 80.05 or vehicles displaying Clean Air Vehicle Decals issued by the California Department of Motor Vehicles pursuant to California Vehicle Code Section 5205.5.

Sec. 6. This ordinance shall remain in effect only until January 1, 2011, or only until California Vehicle Code Section 5205.5 is repealed, whichever occurs first, and as of that date the ordinance is repealed.

Sec. 7. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.

TRANSPORTATION COMMITTEE REPORT relative to amending Sections 88.00, 88.07, 88.13, 88.57 and 88.63 of the Los Angeles Municipal Code (LAMC) to provide for free parking of certain alternative fuel vehicles.

Recommendations for Council action:

- 1. REQUEST the City Attorney to PREPARE and PRESENT an ORDINANCE amending LAMC Sections 88.00, 88.07, 88.13, 88.57 and 88.63 to:
  - a. Establish an hourly rate of \$0.00 (i.e. free) for Alternate Fuel Vehicles properly displaying California Department of Motor Vehicles (DMV) Clean Air Vehicle Decals at all Department of Transportation (DOT) on- and off-street parking meters in the City of Los Angeles until January 1, 2011.
  - b. Exempt Alternate Fuel Vehicles properly displaying DMV Clean Air Vehicle Decals from the requirements to deposit coins in parking meters at DOT on- and off-street parking meters in the City of Los Angeles managed by the DOT until January 1, 2011.
- 2. DIRECT the DOT to extend the Free Metered Parking Pilot Program for Hybrid Vehicles as currently configured until the Ordinance modifying the program as described above in Recommendation No. 1 becomes effective.
- 3. DIRECT the DOT to publicize the changes to the Free Metered Parking Pilot Program for Hybrid Vehicles once the Ordinance described above in Recommendation No. 1 becomes effective.
- 4. DIRECT the DOT to issue warning notices instead of citations to any of the four, previously eligible, hybrid vehicles observed parked at expired City parking meters without properly displaying DMV Clean Air Vehicle Decals for 30 days after the Ordinance described above in Recommendation No. 1 becomes effective.

<u>Fiscal Impact Statement</u>: The DOT reports that at this time, only 496 eligible hybrid vehicles have been observed participating in the free metered parking pilot program resulting in an estimated annual revenue loss of between \$116,560 or approximately 0.56% of total annual meter revenue. In spite of the potential for increased levels of hybrid ownership, the recommended linking of the program with the DMV's Clean Air Vehicle decal program, with its cap of 85,000 total decals, is expected to limit any further decrease in parking meter revenue to the Special Parking Revenue Fund as well as any reduction in General Fund revenue from parking citations issued for parking meter violations.

Subsequent to the June 21, 2006 Council direction to draft the City's enabling Ordinance with a

January 1, 2008 expiration date, California Vehicle Code Section (CVC) 5205.5 was extended until January 1, 2011. The attached Ordinance is worded to "remain in effect only until January 1, 2008, or only until CVC 5205.5 is repealed, whichever occurs first, and as of that date is repealed." With the extension of the Clean Air Vehicle Decal Program until as late as January 1, 2011, the Council may wish to change their instructions regarding the expiration date for the City's enabling Ordinance.

## Summary:

On June 21, 2008, Council requested the City Attorney to prepare and present an Ordinance amending LAMC Sections 88.00, 88.07, 88.13, 88.57 and 88.63 by:

- a. Establishing an hourly rate of \$0.00 (i.e. free) for Alternate Fuel Vehicles properly displaying California Department of Motor Vehicles (DMV) Clean Air Vehicle Decals at all DOT on- and off-street parking meters in the City of Los Angeles.
- b. Exempting Alternate Fuel Vehicles properly displaying DMV Clean Air Vehicle Decals from the requirements to deposit coins in parking meters at DOT on- and off-street parking meters in the City of Los Angeles until January 1, 2008.

Additionally, Council directed the DOT to extend the Free Metered Parking Pilot Program for Hybrid Vehicles as currently configured until the Ordinance modifying the program as described above in Recommendation No. 2 becomes effective.

Subsequently, on October 10, 2007 and December 3, 2007, your Committee considered October 3, 2007 DOT report, September 5, 2007 City Attorney report, and Ordinance relative to amending LAMC Sections 88.00, 88.07, 88.13, 88.57 and 88.63 as previously requested by Council on June 21, 2006. According to the DOT, on September 28, 2004, Council directed the DOT to modify its parking enforcement policy to add four designated hybrid vehicles (Toyota Prius, Honda Civic Hybrid, Honda Insight and Ford Escape Hybrid) to the existing Zero Emission Vehicle/Super Ultra Low Emission Vehicle (ZEV/SULEV) Free Metered Parking Program for the period from October 1, 2004 through March 31, 2005.

The current parking enforcement policy allows vehicles with Clean Air Vehicle decals issued by the California Department of Motor Vehicles (DMV) to park for free at City parking meters as long as they obey all posted time limits and higher-order parking restrictions. The four hybrid vehicle models were added to the list of vehicles eligible to receive the free parking benefits of the program but were not required to display the Clean Air Vehicle decals. Subsequently, on March 23, 2005 Council extended the Program to May 31, 2005, and once again on May 3, 2005 to further extend the Program to June 30, 2006. Finally, on June 21, 2006, Council extended the Program until January 1, 2008.

The number of vehicles participating in the Program was sampled on June 1, 2006 and again on January 18, 2007. On these dates, Traffic Officers throughout the City were instructed to record every eligible hybrid vehicle they saw parked at a City meter. During a typical ten-hour day (8:00 am to 6:00 pm), Traffic Officers recorded the time of observation, vehicle license plate number and parking meter number. This allowed the DOT to identify how many observations were of the same vehicle at the same meter on successive passes of the Traffic Officer. The 2006 survey yielded 261 observations of eligible hybrid vehicles parked at City meters, representing only 218 different

hybrid vehicles. The 2007 survey recorded 580 observations of eligible hybrid vehicles at City meters, representing 496 different hybrid vehicles- a 128% increase during the seven months between the two surveys.

The DOT then stated that parking meter rates in the City range from \$0.25 to \$2.00 per hour. Based upon the number of meters charging a particular rate, the DOT has determined the weighted average parking meter rate in the City to be \$0.47 per hour. Assuming that each of the 496 hybrid vehicles observed on January 18, 2007 represented a vehicle parked for free for the typical time limit of two hours at the weighted average meter rate of \$0.47 per hour, the estimated annual revenue loss would be \$116,560 (e.g., 496 vehicles per day x 2 hours x \$0.47/hour x 250 operating days/year). Finally, the DOT noted that the State has extended the Clean Air Vehicle Decal Program until as late as January 1, 2011.

After further consideration and having provided an opportunity for public comment, the Committee moved to recommend requesting the City Attorney to prepare an Ordinance to amend the LAMC to provide for free parking of alternative fuel vehicles that are included in the Clean Air Vehicle Decal Program until as late as January 1, 2011. Additionally, the Committee moved to recommend approval of the recommendations as contained in the October 3, 2007 DOT report and detailed above in Recommendation Nos. 2-4. This matter is now being forwarded to the Council for its consideration.

# **DISCUSSION:**

On September 28, 2004, the City Council directed the Department of Transportation (DOT) to modify its parking enforcement policy to add four designated hybrid vehicles to the existing Zero Emission Vehicle/Super Ultra Low Emission Vehicle (ZEV/SULEV) free metered parking program for the period from October 1, 2004 through March 31, 2005. The City Council subsequently extended the hybrid pilot program until June 30, 2006. On June 21, 2006, the Council took the following actions:

- 1. Requested that the City Attorney prepare and present an ordinance amending Sections 88.00, 88.07, 88.13, 88.57 and 88.63 of the Los Angeles Municipal Code to make the program "permanent" by:
  - a. Establishing an hourly rate of \$0.00 (i.e., free) for Alternate Fuel Vehicles properly displaying California Department of Motor Vehicle (DMV) Clean Air Vehicle Decals at all Department of Transportation (DOT) on- and off-street parking meters in the City of Los Angeles until January 1, 2008.
  - b. Exempting Alternate Fuel Vehicles properly displaying California DMV Clean Air Vehicle Decals from the requirements to deposit coins in parking meters at DOT on- and off-street parking meters in the City of Los Angeles until January 1, 2008.
- 2. Directed DOT to extend the free metered parking pilot program for hybrid vehicles as currently configured until the ordinance modifying the program as described above is in effect.

Pursuant to Council action, DOT has continued to allow the four hybrid vehicle models that were part of the Council's pilot program to park for free at on- and off-street parking meters managed by DOT while DOT staff worked with the City Attorney's office to draft an ordinance making the program "permanent". The City Attorney has drafted the requested ordinance, approved it as to form and legality and forwarded it to the City Council (copy attached).

# Background

The Council action establishing this pilot program for hybrid vehicles added four eligible hybrid vehicles (Toyota Prius, Honda Civic Hybrid, Honda Insight and Ford Escape Hybrid) to the City's existing ZEV/SULEV free metered parking pilot program. This was accomplished by revising the current parking enforcement policy that allows vehicles with Clean Air Vehicle decals issued by the California Department of Motor Vehicles to park for free at City parking meters as long as they obey all posted time limits and higher-order

parking restrictions (e.g., Tow Away No Stopping during peak periods, No Parking Street Cleaning, etc.). The four hybrid vehicle models were added to the list of vehicles eligible to receive the free parking benefits of this program but were not required to display Clean Air Vehicle decals. The Department's Traffic Officers were trained to recognize these four eligible vehicles and afford them the same free parking privileges as vehicles with Clean Air Vehicle decals. The required enforcement policy revision was prepared, adopted by the Board of Transportation Commissioners and implemented in the field on October 1, 2004. The DOT website was also updated to reflect the inclusion of the four hybrid vehicles in the Free Metered Parking program.

# Participation in the Pilot Program

The number of vehicles participating in the free metered parking pilot program for hybrid vehicles was sampled on June 1, 2006, and again on January 18, 2007. On these dates Traffic Officers throughout the City of Los Angeles were instructed to record every eligible hybrid vehicle they saw parked at a City meter. During a typical ten-hour day (8:00 a.m. to 6:00 p.m.), Traffic Officers recorded time of observation, vehicle license plate number, and parking meter number. This allowed DOT to identify how many observations were of the same vehicle at the same meter on successive passes of the Traffic Officer. The 2006 survey yielded 261 observations of eligible hybrid vehicles. The 2007 survey recorded 580 observations of eligible hybrid vehicles. The 2007 survey recorded 580 observations of eligible hybrid vehicles parked at City meters, representing 496 different hybrid vehicles – a 128 percent increase during the seven months between the two surveys.

#### DMV Clean Air Vehicle Decal Program

California Vehicle Code (CVC) Section 5205.5 authorizes the California Department of Motor Vehicles (DMV) to issue distinctive decals to vehicles that meet certain fuel economy and/or exhaust emission standards. Currently, Clean Air Vehicle Decals with a white background are issued to vehicles meeting super ultra-low emission vehicle (SULEV) standards; and Clean Air Vehicle Decals with a yellow background are issued to hybrid vehicles or alternative fuel vehicles with a 45 miles per gallon or greater highway mileage rating and that meet California's advanced technology partial zero-emission vehicle (PZEV), ultra-low emission vehicle (ULEV), SULEV or partial zero-emission vehicle (PZEV) standards.

Of the four hybrid vehicles eligible for free metered parking in the City's pilot program (Toyota Prius, Honda Civic Hybrid, Honda Insight and Ford Escape Hybrid), both the Ford Escape Hybrid (does not meet mileage standard) and the Honda Insight from the 2005 model year on (does not meet AT PZEV standard) do not qualify for Clean Air Vehicle Decals. However, these two models represent only one percent and four percent, respectively, of all hybrids observed during the Traffic Officer surveys.

CVC Section 5205.5 originally authorized the issuance of no more than 75,000 Clean Air Vehicle Decals to hybrid and alternative fuel vehicles, and the law authorizing the issuance

of the Clean Air Vehicle Decals (both white and yellow backgrounds) contains "sunset" language automatically repealing the law no later than January 1, 2008.

On January 1, 2007, the State Legislature amended CVC Section 5205.5 to allow an additional 10,000 Clean Air Vehicle Decals to be issued to hybrid and alternative fuel vehicles and extended the automatic repeal date to January 1, 2011. By February 2007, the DMV had issued all 85,000 authorized decals.

On September 12, 2007, the Los Angeles Times reported that the Federal Highway Administration had declared that California's carpool lanes were not meeting federal requirements to flow at speeds of 45 miles per hour or faster at rush hour. Since CVC Section 5205.5 allows single occupant vehicles with Clean Air Vehicle Decals to use the state's carpool lanes, the federal declaration may force the DMV to terminate the Clean Air Vehicle Decal program prematurely to avoid the loss of federal highway funds.

### Revenue Loss from the Hybrid Pilot Program

Parking meter rates in the City of Los Angeles range from \$0.25 to \$2.00 per hour. Based upon the number of meters charging a particular meter rate, DOT has determined the weighted average parking meter rate in the City to be \$0.47 per hour. Assuming that each of the 496 hybrid vehicles observed on January 18, 2007, represented a vehicle parked for free for the typical maximum time limit of two hours at the weighted average meter rate of \$0.47 per hour, the estimated annual revenue loss would be \$116,560 (e.g., 496 vehicles/day X 2 hours X \$0.47/hour X 250 operating days/year).

With total anticipated meter revenues this fiscal year of approximately \$21.0 million, the projected loss of revenue represents less than a 0.56 percent reduction in annual meter revenue.

# CONCLUSION

Due to the success of the free metered parking pilot program in achieving higher levels of hybrid vehicle ownership and the current, relatively small financial impact on City meter revenues, the Council asked the City Attorney to make the program "permanent" through changes to existing City ordinances but limiting eligibility to vehicles with Clean Air Vehicle decals issued by the California DMV. The Council directed the City Attorney to draft the City's enabling ordinance to expire on January 1, 2008, when the Clean Air Vehicle Decal program was due to be repealed.

# FISCAL IMPACT STATEMENT:

At this time only 496 eligible hybrid vehicles have been observed participating in the free metered parking pilot program on a typical day resulting in an estimated annual revenue loss of \$116,560, or approximately 0.56 percent of total annual meter revenue. In spite of the potential for increased levels of hybrid ownership, linking the City's program to the DMV's Clean Air Vehicle decal program, with its cap of 85,000 total decals, is expected to

limit any further decrease in parking meter revenue to the Special Parking Revenue Fund as well as any reduction in General Fund revenue from parking citations issued for parking meter violations.

Subsequent to the Council direction to draft the City's enabling ordinance with a January 1, 2008, expiration date, CVC Section 5205.5 was extended until January 1, 2011. The attached ordinance is worded to "remain in effect only until January 1, 2008, or only until California Vehicle Code Section 5205.5 is repealed, whichever occurs first, and as of that date is repealed". With the extension of the Clean Air Vehicle Decal program until as late as January 1, 2011, the Council may wish to change their instructions regarding the expiration date for the City's enabling ordinance.

TRANSPORTATION COMMITTEE REPORT relative to the Free Metered Parking Pilot Program for Hybrid Vehicles.

Recommendations for Council action:

- 1. FIND that the pilot program enabling certain hybrid vehicles to park for free at City parking meters is achieving the goal of increasing the sales of hybrid vehicles.
- 2. REQUEST the City Attorney to prepare and present an Ordinance amending Sections 88.00, 88.07, 88.13, 88.57 and 88.63 of the Los Angeles Municipal Code (LAMC) to make the Free Metered Parking Pilot Program for hybrid vehicles permanent by:
  - a. Establishing an hourly rate of \$0.00 (i.e. free) for Alternate Fuel Vehicles properly displaying California Department of Motor Vehicles (DMV) Clean Air Vehicle Decals at all Department of Transportation (DOT) on- and off-street parking meters in the City of Los Angeles.
  - b. Exempting Alternate Fuel Vehicles properly displaying DMV Clean Air Vehicle Decals from the requirements to deposit coins in parking meters at Department of Transportation (DOT) on- and off-street parking meters in the City of Los Angeles until January 1, 2008.
- 3. DIRECT the DOT to extend the Free Metered Parking Pilot Program for Hybrid Vehicles as currently configured until the Ordinance modifying the program as described above in Recommendation No. 2.
- 4. DIRECT the DOT to publicize the changes to the Free Metered Parking Pilot Program for Hybrid Vehicles once the Ordinance described above in Recommendation No. 2 becomes effective.
- 5. DIRECT the DOT to issue warning notices instead of citations to any of the four, previously eligible, hybrid vehicles observed parked at expired City parking meters without properly displaying DMV Clean Air Vehicle Decals for 30 days after the Ordinance described above in Recommendation No. 2 becomes effective.
- 6. DIRECT the DOT to report back to Council in 6 months relative to the status of the Free Metered Parking Pilot Program for Hybrid Vehicles.

<u>Fiscal Impact Statement</u>: The DOT reports that at this time, only 261 eligible hybrid vehicles have been observed participating in the free metered parking pilot program resulting in an estimated annual revenue loss of between \$32,500 and \$65,000, or less than 0.31% of total annual meter

revenue. In spite of the potential for increased levels of hybrid ownership, the recommended linking of the program with the DMV's Clean Air Vehicle decal program is expected to limit any further decrease in parking meter revenue to the Special Parking Revenue Fund as well as any reduction in General Fund revenue from parking citations issued for parking meter violations.

#### Summary:

On September 28, 2004, Council directed the DOT to modify its parking enforcement policy to add four designated hybrid vehicles (Toyota Prius, Honda Civic Hybrid, Honda Insight and Ford Escape Hybrid) to the existing Zero Emission Vehicle/Super Ultra Low Emission Vehicle (ZEV/SULEV) Free Metered Parking Program for the period from October 1, 2004 through March 31, 2005. The current parking enforcement policy allows vehicles with Clean Air Vehicle decals issued by the California Department of Motor Vehicles (DMV) to park for free at City parking meters as long as they obey all posted time limits and higher-order parking restrictions. The four hybrid vehicle models were added to the list of vehicles eligible to receive the free parking benefits of the program but were not required to display the Clean Air Vehicle decals. Subsequently, on March 23, 2005 Council extended the Program to May 31, 2005 and once again on May 3, 2005 to further extend the Program to June 30, 2006.

At its June 14, 2006 meeting, your Committee considered a June 2, 2006 DOT report relative to the Free Metered Parking Pilot Program for Hybrid Vehicles. According to the DOT, due to the success of the Program in achieving higher levels of hybrid vehicle ownership and the current, relatively small financial impact on City meter revenue, the DOT is recommending making the Program permanent through changes to existing City Ordinances but limiting eligibility to vehicles with Clean Air Vehicle decals issued through the DMV. LAMC Section 88.00 would need to be amended to establish a Citywide hourly rate of \$0.00 for eligible hybrid vehicles at all DOT on-street parking meters, and LAMC Section 88.57 would need a similar amendment to establish the same hourly rate at meters in the DOT's off-street parking lots. Several sections of the LAMC (e.g., 88.07, 88.13, 88.57 and 88.63) would also need to be amended to exempt the drivers of eligible hybrid vehicles from the requirement to immediately deposit money in the meter when parking at DOT's on- and off-street parking meters and to exempt the drivers of eligible hybrid vehicles from the penalties for failure to do so.

After further consideration and having provided an opportunity for public comment, the Committee moved to recommend approval of the recommendations as contained in the June 2, 2006 DOT report. Additionally, the Committee moved to recommend directing the DOT to report back to Council in 6 months relative to the status of the Free Metered Parking Pilot Program for Hybrid Vehicles.

This matter is now being forwarded to the Council for its consideration.

On September 28, 2004, the City Council directed the Department of Transportation (DOT) to modify its parking enforcement policy to add four designated hybrid vehicles to the existing Zero Emission Vehicle/Super Ultra Low Emission Vehicle (ZEV/SULEV) free metered parking program for the period from October 1, 2004 through March 31, 2005. On March 23, 2005, the City Council extended the hybrid pilot program until May 31, 2005. On May 31, 2005, the Council directed DOT to extend the pilot program again to a new termination date of June 30, 2006, and to:

- 1. Publicize the free, metered parking for hybrid vehicles pilot program.
- 2. Monitor participation in the program.
- 3. Report back to the Council by May 1, 2006, with information on the current number of hybrid vehicles registered statewide and an analysis of future cost and revenue impacts beyond the pilot period with recommendations whether and how to continue the program.

The Council action establishing this pilot program for hybrid vehicles added four eligible hybrid vehicles (Toyota Prius, Honda Civic Hybrid, Honda Insight and Ford Escape Hybrid) to the City's existing ZEV/SULEV free metered parking pilot program. This was accomplished by revising the current parking enforcement policy that allows vehicles with Clean Air Vehicle decals issued by the California Department of Motor Vehicles to park for free at City parking meters as long as they obey all posted time limits and higher-order parking restrictions (e.g., Tow Away No Stopping during peak periods, No Parking Street Cleaning, etc.). The four hybrid vehicle models were added to the list of vehicles eligible to receive the free parking benefits of this program but were not required to display Clean Air Vehicle decals. The Department's Traffic Officers were trained to recognize these four eligible vehicles and afford them the same free parking privileges as vehicles with Clean Air Vehicle decals. The required enforcement policy revision was prepared, adopted by the Board of Transportation Commissioners and implemented in the field on October 1, 2004. The DOT website was also updated to reflect the inclusion of the four hybrid vehicles in the Free Metered Parking program. The 21-month pilot program will end at midnight on June 30, 2006, if the City Council does not act to extend the program.

#### Publicizing the Free Metered Parking Pilot Program for Hybrid Vehicles

Subsequent to the Council's May 31, 2005, action, DOT staff updated the City's 3-1-1 Community Services Directory (<u>www.lacity.org</u>) and the DOT website (<u>www.lacity.org/ladot/freepark.htm</u>) to include the June 30, 2006, expiration date and added language to more fully explain the free parking program and identify the eligible hybrid models. Information on the pilot program was also provided to several media outlets, other Internet websites and "blogs". Information on the City's pilot program is now featured on such national websites as the Alternative Fuels Data Center webpage maintained by the U.S. Department of Energy (<u>www.eere.energy.gov/afdc</u>).

#### Participation in the Pilot Program

The number of vehicles participating in the free metered parking pilot program for hybrid vehicles was sampled on two occasions. On Thursday, April 7, 2005, just over six months into the pilot program, Traffic Officers throughout the City of Los Angeles were instructed to record every eligible hybrid vehicle they saw parked at a City meter. During this typical ten-hour day (8:00 a.m. to 6:00 p.m.), a total of 217 eligible hybrids were observed. The same survey was performed approximately 14 months later on Thursday, June 1, 2006. The 2006 survey yielded 261 observations of eligible hybrid vehicles parked at City meters – a 20 percent increase.

#### **Current Number of Hybrid Vehicles**

DOT staff has not yet been able to obtain information from the DMV on the current number of hybrids registered statewide. However, information from hybrid vehicle websites on the Internet indicates that the California DMV is issuing Clean Air Vehicle decals to qualified hybrid vehicles at a rate of approximately 1,000 per month with about 60,000 decals issued statewide since the program began in January 2006.

#### Revenue Loss from the Hybrid Pilot Program

Assuming that each of the 284 hybrid vehicle observations on June 1, 2006, represented a vehicle parked for free for the typical maximum time limit of two hours at a typical meter rate of \$0.25 to \$0.50 per hour, the estimated annual revenue loss would be between \$35,500 and \$71,000 (e.g., 284 vehicles X 2 hours X \$0.25/hour X 250 operating days/year = \$35,500/year).

With total anticipated meter revenues this fiscal year of approximately \$21.0 million, the projected loss of revenue represents less than a 0.34 percent reduction in annual meter revenue.

#### **Hybrid Vehicle Incentives**

The free, metered parking pilot program was one of several incentives designed to encourage purchases of hybrid vehicles. The other major incentives, federal income tax credits and single occupant use of California carpool lanes, both have "sunset" Honorable Wendy Greuel

clauses that will phase out the incentives once a certain level of participation has been reached or by a fixed date, whichever comes first. The federal tax credits for hybrid vehicles will not be offered for vehicles purchased after December 31, 2010, and will begin to be phased out for each manufacturer once the manufacturer has sold 60,000 hybrid and lean-burn vehicles starting from January 2006. California's law (California Vehicle Code Section 5205.5) allowing hybrid vehicles that have a 45 miles per gallon or greater fuel economy highway rating to use the State's high-occupancy vehicle lanes with only a single occupant will be automatically repealed on January 1, 2008. CVC Section 5205.5 also limits the number of Clean Air Vehicle decals that may be issued to qualified hybrid vehicles to 75,000 statewide.

When the City's pilot program was begun in October 2004, hybrid vehicles were not eligible to be issued Clean Air Vehicle Decals. The passage of CVC Section 5205.5 and federal legislation allowing states to determine under what conditions single occupant vehicles could use carpool lanes have led to approximately 60 percent of eligible hybrid owners in the Los Angeles area acquiring the Clean Air Vehicle decals, based on DOT's June 1, 2006, survey.

#### Long-Term Fiscal Impact

Although the current financial loss associated with the free metered parking pilot program for hybrid vehicles does not represent a substantial loss in meter revenue at this time, continued growth in hybrid vehicle ownership as well as the ever-increasing number of hybrid vehicle models could result in a significant impact on meter revenue if the list of eligible vehicles were expanded or their numbers were not controlled in some way. The current program also continues to cause confusion with the public and with DOT Traffic Officers because only certain hybrid vehicle models are eligible for the free metered parking incentive, and those eligible models may or may not be eligible for or have Clean Air Vehicle decals. Therefore, DOT recommends limiting the potential long-term financial loss to the City and simplifying the public education and enforcement of the program by extending the free metered parking benefit to only those hybrid vehicles that properly display a Clean Air Vehicle decal issued by the California DMV. This approach would ensure that no more than 75,000 hybrids statewide would be eligible to receive this parking benefit and that the benefit would expire on January 1, 2008, when CVC Section 5205.5 is automatically repealed.

#### CONCLUSION

Due to the success of the free metered parking pilot program in achieving higher levels of hybrid vehicle ownership and the current, relatively small financial impact on City meter revenues, DOT recommends making the program permanent through changes to existing City ordinances but limiting eligibility to vehicles with Clean Air Vehicle decals issued by the California DMV. Los Angeles Municipal Code (LAMC) Section 88.00 would need to be amended to establish a Citywide hourly rate \$0.00 for eligible hybrid vehicles at all DOT on-street parking meters, and LAMC Section 88.57 would need a similar amendment to establish the same hourly rate at meters in DOT's off-street parking lots. Several sections of the LAMC (e.g., 88,07, 88.13, 88.57 and 88.63) would Honorable Wendy Greuel

also need to be amended to exempt the drivers of eligible hybrid vehicles from the requirement to immediately deposit money in the meter when parking at DOT's on- and off-street parking meters and to exempt the drivers of eligible hybrid vehicles from the penalties for failure to do so.

#### FISCAL IMPACT STATEMENT:

At this time only 261 eligible hybrid vehicles have been observed participating in the free metered parking pilot program resulting in an estimated annual revenue loss of between \$32,500 and \$65,000, or less than 0.31 percent of total annual meter revenue. In spite of the potential for increased levels of hybrid ownership, the recommended linking of the program to the DMV's Clean Air Vehicle decal program is expected to limit any further decrease in parking meter revenue to the Special Parking Revenue Fund as well as any reduction in General Fund revenue from parking citations issued for parking meter violations.

### **COORDINATION:**

This matter has been discussed with staff of Council District 13 and is also being presented for comment to the Board of Transportation Commissioners, the designated administrators of the Special Parking Revenue Fund into which all meter revenues are deposited.

#### **RECOMMENDATIONS:**

#### DISCUSSION:

On September 28, 2004, the City Council directed the Department of Transportation to modify its parking enforcement policy to add four designated hybrid vehicles to the existing ZEV/SULEV free metered parking program for the period from October 1, 2004 through March 31, 2005, and directed the DOT to report back to the Council at the conclusion of the six-month hybrid vehicle pilot program with an analysis of future cost and revenue impacts beyond the pilot period and recommendations on whether and how to continue the program. On March 23, 2005, the City Council extended the hybrid pilot program to a new termination date of May 31, 2005, and directed the DOT to report to Transportation Committee on how it had explained this program extension to its staff, to ensure that meter enforcement personnel were aware that they should not ticket hybrid vehicles that were parked at City parking meters and were in compliance with posted time limits through May 31, 2005.

The Council action establishing this pilot program for hybrid vehicles added four eligible hybrid vehicles (Toyota Prius, Honda Civic Hybrid, Honda Insight and Ford Escape Hybrid) to the City's existing Zero Emission Vehicle/Super Ultra Low Emission Vehicle (ZEV/SULEV) free metered parking pilot program. During this typical tenhour day (8:00 a.m. to 6:00 p.m.), a total of 217 eligible hybrids were observed. Assuming that each vehicle parked for free for the typical maximum time limit of two hours at a typical meter rate of \$0.25 to \$0.50 per hour, the estimated annual revenue loss would be between \$27,000 and \$54,000 (e.g., 217 vehicles X 2 hours X \$0.25/hour X 250 operating days/year = \$27,125/year).

With total anticipated meter revenues this fiscal year of approximately \$21.5 million, the projected loss of revenue represents less than a 0.25 percent reduction in annual meter revenue.

#### **Public Reaction**

The DOT has received several complimentary letters and e-mails from hybrid owners who are participating in the program (see attached sample). Although it has been argued that no one would decide to buy a hybrid vehicle solely on the basis of the free metered parking in Los Angeles, it is clear that hybrid users view this and other potential benefits (perhaps someday being able to drive alone in carpool lanes throughout the state) as positive reinforcement for their decision to buy a hybrid vehicle.

#### Long-Term Fiscal Impact

If this program were to be extended on a permanent basis, better publicity and an increasing number of registered hybrid vehicles would ultimately begin to produce concerns about significant reductions in meter revenue just as concerns have been raised about potential congestion in carpool lanes as greater and greater numbers of single-passenger hybrid vehicles take advantage of this proposed statewide benefit. One way to address this concern would be to take the same approach that has been proposed at the state level, i.e., to eliminate hybrid incentives once a certain level of market penetration/vehicle ownership has been achieved. For example, Assembly Bill

2628 (Pavley) prohibits the DMV from issuing more than 75,000 decals allowing singleoccupant, low emission vehicles to use carpool lanes.

# Parking Enforcement during Two-Month Program Extension

Meter enforcement personnel were aware of the two-month program. As soon as DOT staff had confirmation that the Council had acted to extend the pilot program from March 31 to May 31, 2005, Management of the Bureau of Parking Enforcement and Traffic Control issued memos to their Area Captains and Lieutenants informing them of the extension and instructing them to conduct roll call training for their Traffic Officers to inform them of the extension. Notices were also sent to the DOT parking citation contractor, ACS, and to DOT staff involved in adjudication of parking citations informing them of the extension. Finally, DOT staff responded to all press queries and e-mails to the DOT website about the extension and updated the DOT website to reflect the extension.

#### FISCAL IMPACT STATEMENT:

At this time only 217 eligible hybrid vehicles have been observed participating in the / free metered parking pilot program resulting in an estimated annual revenue loss of between \$27,000 and \$54,000, or less than 0.25 percent of total annual meter revenue. In spite of the potential for increased levels of hybrid ownership, the recommended extension of the pilot program for an additional 13 months is expected to result in a negligible decrease in parking meter revenue to the Special Parking Revenue Fund as well as some reduction in General Fund revenue from parking citations issued for parking meter violations.

This matter is also being presented for comment to the Board of Transportation Commissioners, the designated administrators of the Special Parking Revenue Fund into which all meter revenues are deposited.

TRANSPORTATION COMMITTEE REPORT relative to extending an eight-month free metered parking pilot program for hybrid vehicles.

Recommendation for Council action:

DIRECT the Department of Transportation (DOT) to:

In spite of the potential for increased levels of hybrid ownership, the recommended extension of the pilot program for an additional 13 months is expected to result in a negligible decrease in parking meter revenue to the Special parking Revenue Fund as well as some reduction in General Fund revenue from parking citations issued for parking meter violations.

#### Summary:

On September 28, 2004, Council directed the DOT to modify its parking enforcement policy to add four designated hybrid vehicles (Toyota Prius, Honda Civic Hybrid, Honda Insight and Ford Escape Hybrid) to the existing Zero Emission Vehicle/Super Ultra Low Emission Vehicle (ZEV/SULEV) free metered parking program for the period from October 1, 2004 through March 31, 2005. The current parking enforcement policy allows vehicles with Clean Air Vehicle decals issued by the California Department of Motor Vehicles (DMV) to park for free at City parking meters as long as they obey all posted time limits and higher-order parking restrictions. The four hybrid vehicle models were added to the list of vehicles eligible to receive the free parking benefits of the program but were not required to display the Clean Air Vehicle decals. Subsequently, on March 23, 2005, Council extended the hybrid pilot program to a new termination date of May 31, 2005.

At its May 25, 2005 meeting, your Committee considered a DOT report relative to the eight-month pilot program enabling certain hybrid vehicles to park for free at City parking meters. According to the DOT, it has received several complimentary letters and e-mails from hybrid owners who are participating in the program. Additionally, the DOT noted that while no one would be likely to purchase a hybrid vehicle solely on the basis of the free metered parking in the City, it is clear that hybrid users view this and other

potential benefits as positive reinforcement of for their decision to purchase a hybrid vehicle.

Finally, the DOT stated that if the free metered parking for hybrid vehicles program was extended on a permanent basis, better publicity and an increasing number of registered hybrid vehicles would ultimately begin to produce concerns about significant reductions in meter revenue. One potential solution to this issue would be to eliminate hybrid incentives once a certain level of market penetration/vehicle ownership has been achieved.

After further consideration and having provided an opportunity for public comment, your Committee moved to approve the recommendations in the DOT report. This matter is now being forwarded to the Council for its consideration.



The Council action establishing this pilot program for hybrid vehicles added four eligible hybrid vehicles (Toyota Prius, Honda Civic Hybrid, Honda Insight and Ford Escape Hybrid) to the City's existing Zero Emission Vehicle/Super Ultra Low Emission Vehicle (ZEV/SULEV) free metered parking pilot program. This was accomplished by revising the current parking enforcement policy that allows vehicles with Clean Air Vehicle decals issued by the California Department of Motor Vehicles to park for free at City parking meters as long as they obey all posted time limits and higher-order parking restrictions (e.g., Tow Away No Stopping during peak periods, No Parking Street Cleaning, etc.). The four hybrid vehicle models were added to the list of vehicles eligible to receive the free parking benefits of this program but were not required to display Clean Air Vehicle decals. The Department's Traffic Officers were trained to recognize these four eligible vehicles and afford them the same free parking privileges as vehicles with Clean Air Vehicle decals. The required enforcement policy revision was prepared, adopted by the Board of Transportation Commissioners and implemented in the field on October 1, 2004. The DOT website was also updated to reflect the inclusion of the four hybrid vehicles in the Free Metered Parking program. The eight-month pilot program will end at midnight on May 31, 2005, if the City Council does not act to extend the program.

# Revenue Loss from the Hybrid Pilot Program

On Thursday, April 7, 2005, just over six months into the pilot program, Parking Enforcement Officers throughout the City of Los Angeles were instructed to record every eligible hybrid vehicle they saw parked at a City meter. During this typical tenhour day (8:00 a.m. to 6:00 p.m.), a total of 217 eligible hybrids were observed. Assuming that each vehicle parked for free for the typical maximum time limit of two hours at a typical meter rate of \$0.25 to \$0.50 per hour, the estimated annual revenue loss would be between \$27,000 and \$54,000 (e.g., 217 vehicles X 2 hours X \$0.25/hour X 250 operating days/year = \$27,125/year).

With total anticipated meter revenues this fiscal year of approximately \$21.5 million, the projected loss of revenue represents less than a 0.25 percent reduction in annual meter revenue.

# **Public Reaction**

The DOT has received several complimentary letters and e-mails from hybrid owners who are participating in the program (see attached sample). Although it has been argued that no one would decide to buy a hybrid vehicle solely on the basis of the free metered parking in Los Angeles, it is clear that hybrid users view this and other potential benefits (perhaps someday being able to drive alone in carpool lanes throughout the state) as positive reinforcement for their decision to buy a hybrid vehicle.

#### Long-Term Fiscal Impact

If this program were to be extended on a permanent basis, better publicity and an increasing number of registered hybrid vehicles would ultimately begin to produce concerns about significant reductions in meter revenue just as concerns have been raised about potential congestion in carpool lanes as greater and greater numbers of single-passenger hybrid vehicles take advantage of this proposed statewide benefit. One way to address this concern would be to take the same approach that has been proposed at the state level, i.e., to eliminate hybrid incentives once a certain level of market penetration/vehicle ownership has been achieved. For example, Assembly Bill 2628 (Pavley) prohibits the DMV from issuing more than 75,000 decals allowing single-occupant, low emission vehicles to use carpool lanes.

#### Parking Enforcement during Two-Month Program Extension

Meter enforcement personnel were aware of the two-month program. As soon as DOT staff had confirmation that the Council had acted to extend the pilot program from March 31 to May 31, 2005, Management of the Bureau of Parking Enforcement and Traffic Control issued memos to their Area Captains and Lieutenants informing them of the extension and instructing them to conduct roll call training for their Traffic Officers to inform them of the extension. Notices were also sent to the DOT parking citation contractor, ACS, and to DOT staff involved in adjudication of parking citations informing them of the extension. Finally, DOT staff responded to all press queries and e-mails to the DOT website about the extension and updated the DOT website to reflect the extension.

#### FISCAL IMPACT STATEMENT:

At this time only 217 eligible hybrid vehicles have been observed participating in the free metered parking pilot program resulting in an estimated annual revenue loss of between \$27,000 and \$54,000, or less than 0.25 percent of total annual meter revenue. In spite of the potential for increased levels of hybrid ownership, the recommended extension of the pilot program for an additional 13 months is expected to result in a negligible decrease in parking meter revenue to the Special Parking Revenue Fund as well as some reduction in General Fund revenue from parking citations issued for parking meter violations.

#### **COORDINATION:**

This matter is also being presented for comment to the Board of Transportation Commissioners, the designated administrators of the Special Parking Revenue Fund into which all meter revenues are deposited.

On October 1, 2004, City Council enacted a 6-Month Pilot Program enabling hybrid vehicles to park at on-street and off-street parking meters in the City without depositing coins as long as they comply with any posted time limits and parking restrictions (Council File 04-1362). This program is an extension of the free parking at City parking meters program for Zero Emission Vehicles (ZEVs) and Super Ultra Low Emission Vehicles (SULEVs) that are designated as "Clean Air Vehicles" by the Department of Motor Vehicles. The Mayor and City Council supported this initiative in an effort to promote ownership of fuel-efficient vehicles and demonstrate environmental leadership. The Department of Transportation (DOT) is currently preparing a report analyzing the future cost and revenue impacts of extending the hybrid program on a permanent basis. However, it is unlikely that DOT and City Council will have sufficient time to fully evaluate the hybrid program by the 6-Month Pilot Program expiration date of March 31, 2005.

I THEREFORE MOVE that the 6-Month Pilot Program enabling hybrid vehicles to park for free at City parking meters be extended to a new termination date of May 31, 2005, so that this program can continue while its long-term financial impacts are under evaluation.

I FURTHER MOVE that the Department of Transportation be directed to report to Transportation Committee how it has explained this program extension to its staff, to ensure that meter-enforcement personnel are aware that they should not ticket hybrid vehicles that are parked at City parking meters and are in compliance of posted time limits through May 31, 2005.

TRANSPORTATION COMMITTEE REPORT relative to initiating a pilot six-month hybrid vehicle free parking at meters program.

Recommendations for Council action, as initiated by Motion (Garcetti - Padilla):

- 1. DIRECT the Department of Transportation (DOT) to modify its parking enforcement policy to add four designated hybrid vehicles to the existing ZEV/SULEV free metered parking program for the period from October 1, 2004 through March 31, 2005.
- 2. DIRECT the DOT to report back to the Council at the conclusion of the six-month hybridvehicle pilot program with an analysis of future cost and revenue impacts beyond the pilot period and making recommendations on whether and how to continue the program.

<u>Fiscal Impact Statement</u>: The DOT reports that there are over 41,000 on- and off-street parking meters in the City of Los Angeles, each of which generates an average of \$2.00 in revenue per day. With only 4701 hybrid vehicles registered in Los Angeles in 2003 and the requirement that hybrid owners move their vehicles before the posted time limit expires, the recommended action is expected to result in a negligible decrease in parking meter revenue to the Special Parking Revenue Fund as well as some reduction in General Fund revenue from parking citations issued for parking meter violations.

# Summary:

At its September 8, 2004 meeting, your Committee considered a September 7, 2004 report, attached to the Council file, from the DOT in response to Motion (Garcetti - Padilla) relative to initiating a pilot six-month hybrid-vehicle-free-parking-at-meters program. During the discussion of this item, the DOT representative provided an overview of the Department's report and responded to related questions by your Committee members.

Your Committee then recommended to direct the DOT to modify its parking enforcement policy to add four designated hybrid vehicles to the existing ZEV/SULEV free metered parking program for the period from October 1, 2004 through March 31, 2005. Your Committee also recommended to direct the DOT to report back to the City Council at the conclusion of the sixmonth hybrid-vehicle pilot program with an analysis of future cost and revenue impact beyond the pilot period and making recommendations on whether and how to continue the program. #### **FISCAL IMPACT STATEMENT:**

There are over 41,000 on- and off-street parking meters in the City of Los Angeles, each of which generates an average 0f \$2.00 in revenue per day. With only 4701 hybrid vehicles registered in Los Angeles in 2003 and the requirement that hybrid owners move their vehicles before the posted time limit expires, the recommended action is expected to result in a negligible decrease in parking meter revenue to the Special Parking Revenue Fund as well as some reduction in General Fund revenue from parking citation issued for parking meter violations.

# **COORDINATION:**

The Department recommends that this matter be put to a vote of the full City Council and presented for comment to the Board of Transportation Commissioners, the designated administrators of the Special Parking Revenue Fund, because it will reduce, to some degree, the amount of parking meter revenue available to fund off-street parking lot development in 13 if the City's 15 Council Districts.

The City currently provides free parking at meters for electric and natural gas cars and trucks designated as "Clean Air Vehicles" by the Department of Motor Vehicles.

Based on the success of this initiative, and in an effort to promote cleaner air, it has been proposed that this program be extended to owners of so-called hybrid vehicles as an incentive to encourage the acquisition and use of fuel-efficient vehicles, to promote reduced auto emissions, and to demonstrate the City's environmental leadership.

Hybrid vehicles, which use a combination of gasoline and electric power, may provide the best potential to increase fuel economy on a miles-per-gallon basis and, consequently, reduce air pollution. Los Angeles had more hybrids registered in 2003 (4,701) than any other city.

The proposal for hybrid vehicle free parking contemplates an initial six month period, from September 1, 2004 through March 31, 2005 in order to provide adequate time to evaluate the use and benefits of the program to the City and hybrid owners. It is also hoped that this will bring focus on the incentives for hybrids during the critical period of their introduction and public acceptance. As the use of hybrid vehicles increases, the Department of Transportation should analyze future cost and revenue impact beyond the pilot period and make a recommendation whether to continue the program. The City of San Jose, CA, has operated a similar program for the past three years.

The proposed program contemplates that initially hybrid owners will not need to do anything special to take advantage of the incentives. Parking enforcement officers would be trained to recognize the types of hybrid vehicles currently on the market and would simply not cite owners of such vehicles for not paying at parking meters. Vehicle owners would still be required to comply with posted time limits. In addition, should the Department of Motor Vehicles decide to include hybrids in the category of "Clean Air Vehicles," then hybrid owners would be required to obtain a sticker from the State to qualify for free parking, as is the current practice with electric and natural gas vehicle owners.

#### ORDINANCE NO.

An ordinance amending Sections 88.00, 88.07, 88.13, 88.57 and 88.63 of Chapter VIII of the Los Angeles Municipal Code to establish a \$0.00 hourly rate and to provide an exemption from the requirement to deposit coins for those vehicles displaying Clean Air Vehicle Decals issued by the California Department of Motor Vehicles when parked at Department of Transportation controlled on- and off-street parking meters in the City of Los Angeles.

## THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. The first paragraph of Section 88.00 of Division U of Chapter VIII of the Los Angeles Municipal Code is amended to read:

#### SEC. 88.00. PARKING METER ZONES AND RATES ESTABLISHED.

The following parking meter zones and hourly rates are hereby established. Notwithstanding the hourly rates specified in this section for each Parking Meter Zone, the rate in every Parking Meter Zone for vehicles displaying Clean Air Vehicle Decals issued by the California Department of Motor Vehicles pursuant to California Vehicle Code Section 5205.5 shall be \$0.00 per hour. Payment of the rates established in this section shall be in accordance with the appropriate schedules established by the Board.

Sec. 2. Section 88.07 of Division U of Chapter VIII of the Los Angeles Municipal Code is amended by adding the following sentence at the end of the section to read:

The provisions of this section shall not apply to vehicles displaying Clean Air Vehicle Decals issued by the California Department of Motor Vehicles pursuant to California Vehicle Code Section 5205.5.

Sec. 3. Subsection (b) of Section 88.13 of Division U of Chapter VIII of the Los Angeles Municipal Code is amended to read:

(b) It shall be unlawful for any person to cause, allow, permit or suffer any vehicle to remain in any parking meter space for more than the time indicated by proper signs placed on the parking meter indicating the maximum parking time allowed in the parking meter space, or during any time the parking meter is indicating that the time has elapsed for which coins of the United States of America have been deposited in the parking meter, provided, however, that the provisions of this section shall not apply to any vehicle described in Section 80.05, vehicles owned by the City of Los Angeles, vehicles displaying Clean Air Vehicle Decals issued by the California Department of Motor Vehicles pursuant to California Vehicle Code Section 5205.5 or vehicles operated pursuant to Sections 88.01.1, 88.03.1 and 88.06.1.

Sec. 4. Section 88.57 of Division U of Chapter VIII of the Los Angeles Municipal Code is amended by adding the following sentence at the end of the section tor ead:

The provisions of this section shall not apply to vehicles displaying Clean Air Vehicle Decals issued by the California Department of Motor Vehicles pursuant to California Vehicle Code Section 5205.5.

Sec. 5. Subsection (b) of Section 88.63 of Division U of Chapter VIII of the Los Angeles Municipal Code is amended to read:

(b) It shall be unlawful for any person to cause, allow, permit or suffer any vehicle to remain in any off-street parking meter space for more than the time indicated by proper signs placed on the off-street parking meter indicating the maximum parking time allowed in the off-street parking meter space, or during any time the off-street parking meter is indicating that the time has elapsed for which coins of the United States of America have been deposited in the off-street parking meter; provided, however, that the provisions of this section shall not apply to any vehicle described in Section 80.05 or vehicles displaying Clean Air Vehicle Decals issued by the California Department of Motor Vehicles pursuant to California Vehicle Code Section 5205.5.

Sec. 6. This ordinance shall remain in effect only until January 1, 2011, or only until California Vehicle Code Section 5205.5 is repealed, whichever occurs first, and as of that date the ordinance is repealed.

Sec. 7. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the entrance to the Los Angeles City Hall; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
