
This office has prepared and now transmits, approved as to form and legality, a draft ordinance amending Sections 80.76.2 and 89.60, Chapter VIII, of the Los Angeles Municipal Code, establishing the fines and penalties for violations of Sections 80.54(h)1 and 80.69(d) of this Code, and of California Vehicle Code sections 21221(a) and 21211(b), concerning the overnight parking of vehicles without permits, the parking of vehicles more than six feet high, and the blocking of a bike lane. ORDINANCE NO. _____

An ordinance adding amending Sections 80.76.2 and 89.60 of Chapter VIII of the Los Angeles Municipal Code to add Section 80.54 (regarding various vehicular parking matters) to the list of civil penalties and to establish penalty provisions applicable to Sections 80.54, 80.69(d), and California Vehicle Code Section 21211(b).

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. Section 80.76.2 of the Los Angeles Municipal Code is amended to add the following in numerical order:

SEC. 80.76.2 CIVIL PENALTIES

SECTION DESCRIPTION

80.54(h)1 OVERNIGHT PARKING WITHOUT PERMIT

Sec. 2. Section 89.60 of the Los Angeles Municipal Code is amended to add the following tiered penalty provisions in numerical order:

SEC. 89.60 AUTHORITY

Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
