
The City's 2007-08 Budget provides funds from the General City Purposes (GCP) to assist local programs that include neighborhood beautification projects and other types of improvements of benefit to residents and businesses. In addition, the Street Furniture Revenue Fund can also be used for such neighborhood improvement projects.

There is a need to design and construct gateway median signs and make other improvements that involve the Chesterfield Square/Angeles Mesa Gateway Median Sign Project. The Los Angeles Neighborhood Initiative (LANI) can perform the necessary work, and sufficient funds are available in the Council District Eight portion of the Street Furniture Revenue Fund and the Council District Eight Real property Trust Fund for this purpose.


I THEREFORE MOVE that the Council:

1. Instruct the Bureau of Street Services to prepare or amend a contract, agreement or other necessary contractual document with the Los Angeles Neighborhood Initiative (LANI), for execution by the Councilmember of the Eighth District, subject to the approval of the City Attorney as to form and legality, for the Chesterfield Square/Angeles Mesa Gateway Median Sign Project;
2. Authorize Council District Eight to enter into a contract, agreement or other necessary contractual document, in the amount of \$200,000, with the Los Angeles Neighborhood Initiative (LANI), for the purpose of performing work associated with the design and construction of gateway median signs and other improvements that involve the Chesterfield Square/Angeles Mesa Gateway Median Sign Project. Said contract, agreement or other necessary contractual document shall describe the services to be provided, including an estimated completion date, and require a detailed accounting of the expenditures to the Board of Public Works - Office of Accounting, within thirty (30) days of completion of the work to be performed;
3. Authorize the Board of Public Works, Office of Accounting, to issue payment in the amount of \$100,000 from the Council District Eight portion of the Street Furniture Revenue Fund No. 43D, Department 50, to the Los Angeles Neighborhood Initiative (LANI), to perform the above-described services;
4. Request and authorize the City Controller to transfer \$100,000 from the Council District Eight Real Property Trust Fund No. 690, to the General City Purposes Fund No. 100-56, Account No. 0708 (Council District 8 Community Services), and allocate that amount therefrom to the Los Angeles Neighborhood Initiative (LANI) for the design and construction of gateway median signs and other improvements associated with the Chesterfield Square/Angeles Mesa Gateway Median Sign Project;
5. Instruct the Director of the Bureau of Street Services, with the assistance of the Board of Public Works, Office of Accounting, to ensure compliance with the above accounting requirements; and
6. Authorize the Chief Legislative Analyst, or his designee, to make technical corrections or clarifications as may be necessary to implement the intent of this Motion.
