Summary:

On May 22, 2018 a Notice of Determination was filed by Department of City Planning (DCP) which included the adoption of the Livable Boulevards Streetscape Plan.

On 6/4/18 eleven documents were approved and filed by DCP relating to the updates to the CTCSP and WLA TIMP, which included the Livable Boulevards Streetscape Plan.

On 6/11/18 a public notice was received of a Special Meeting to be held by the City Council's Transportation Committee (TC) on 6/13/18 concerning review and approval of above-mentioned eleven documents, with subsequent referral to City Council's PLUM.

WHEREAS implementing the Livable Boulevards Streetscape Plan would profoundly impact all users of all streets throughout Mar Vista, even while the scope and extent of this plan remains largely unknown within the community,

THEREFORE the Mar Vista Community Council urges City Council TC members Honorable Bonin, Koretz and Martinez, along with the DCP, to clarify the scope and purpose of this plan via community meetings where stakeholders have the opportunity to ask questions directly of the officials in charge of its implementation. Mar Vistans would like to better understand the decision making and funding processes governing the proposal for the Livable Boulevards Streetscape Plan.
