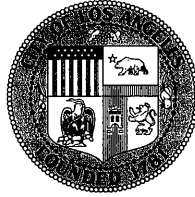

COMMUNICATION FROM CHAIR, EDUCATION AND NEIGHBORHOODS COMMITTEE relative to an application to name a community Reseda Ranch.

Recommendations for Council action:

1. APPROVE the application to name a community Reseda Ranch, bounded roughly by Roscoe Boulevard on the North, Saticoy Street from Aliso Creek to Tampa Avenue and Strathern Street from Tampa Avenue to Corbin on the South, Aliso Creek on the West and Tampa Avenue from Saticoy Street to Strathern Street and Corbin from Strathern Street to Roscoe Boulevard on the West.
2. INSTRUCT all relevant departments to perform the necessary requirements to effectuate the naming of this community, including but not limited to, the installation of signs.

Fiscal Impact Statement: Neither the Chief Legislative Analyst nor the City Administrative Officer have completed a financial analysis of this report.

Summary:

On July 23, 2007, the Chair of the Education and Neighborhoods Committee considered the application to name a community Reseda Ranch, bounded roughly by Roscoe Boulevard on the North, Saticoy Street from Aliso Creek to Tampa Avenue and Strathern Street from Tampa Avenue to Corbin on the South, Aliso Creek on the West and Tampa Avenue from Saticoy Street to Strathern Street and Corbin from Strathern Street to Roscoe Boulevard on the West. The Department of Neighborhood Empowerment has submitted documentation on behalf of the Reseda Neighborhood Council stating that a public hearing was held by the Reseda Neighborhood Council at its meeting on December 18, 2006 with the Board voting 14 to 1 in favor of the application. In addition, the following departments have reviewed the application and have found no conflicts concerning the naming of this community: City Clerk, City Planning, Community Redevelopment Agency, Public Works-Bureau of Engineering, and the Department of Transportation. During the discussion of this matter, the applicant presented background information concerning the community and addressed related questions from the Committee Chair. In addition, a representative from the office of Councilmember Dennis Zine expressed the Councilmember's support for the application. After some discussion and an opportunity for public comment, the Committee Chair recommended to approve the application to name a community Reseda Ranch. This matter is now forwarded to Council for its consideration.
