## MOTION

APR 17 2009

All Access Entertainment is sponsoring the "L.A. Fiesta Broadway 2009" on April 26, 2009, from 12:00 Noon to 6:00 P.M. This is the 20<sup>th</sup> Annual Fiesta Broadway (Cinco de Mayo Celebration) that is open to the public. The activities of this event will include: Four Stages for Entertainment and Performers; Food; Arts & Crafts; and Booths for Sponsors along Broadway, between First Street and Eleventh Street. Approximately 120,000 people are expected to attend this event.

Council District Fourteen has received a request that the City provide certain services and declare this function a Special Event. The fees and costs associated with the facilitation of this event by City personnel have been estimated at \$260,586.00, and the Event Sponsor has agreed to reimburse the City \$80,000.00 of the estimated amount. Approval of this request will mean that an estimated \$180,586 in fees and salary costs will be absorbed by the City. (Event Coordinator: Julio Garcia, II - 310/914-1923 and Fax No. 310/914-9085).

I THEREFORE MOVE that the "L.A. Fiesta Broadway 2009" be declared a Special Event, and City departments be requested to waive all fees and costs, except insurance and application requirements.

I FURTHER MOVE that the Event Sponsor be directed to fulfill the insurance requirements of the City by contacting the Bureau of Street Services - Street Use Inspection Division at 213/847-6000 to obtain, and complete, the necessary insurance forms, upon adoption of this Motion by the City Council.

I FURTHER MOVE that pursuant to Ordinance No. 150,567 relating to temporary street closures, the following streets be closed on April 26, 2009, as indicated below, subject to the supervision of the Director of the Bureau of Street Services:

- Broadway between Temple and First Streets and North curb lane of First Street between Spring Street and Hill Street from 7:00 P.M. on Friday, April 24, 2009 through 5:00 A.M. on Monday, April 27, 2009.
- Broadway between First and Eleventh Streets from 7:00 P.M. on Saturday, April 25, 2009 through 5:00 A.M. on Monday, April 27, 2009. Eighth and Ninth Streets will remain open until 1:00 A.M. on Sunday, April 26, 2009.
- Main Street between Ninth and Eleventh Streets from 7:00 P.M. on Saturday, April 25, 2009 through 5:00 A.M. on Monday, April 27, 2009.
- Hill Street between Sixth Street and Eighth Street from 7:00 P.M. on Saturday, April 25, 2009 through 5:00 A.M. on Monday, April 27, 2009.
- All East-West streets from First Street to Sixth Street, between Spring and Hill Streets, from 7:00 P.M. on Saturday, April 25, 2009 through 5:00 A.M. on Monday, April 27, 2009.
- East-West on Seventh Street between Spring and Olive Streets from 7:00 P.M. on Saturday, April 25, 2009 through 5:00 A.M. on Monday, April 27, 2009.
- East-West on Eighth Street between Spring and Hill Streets from 1:00 A.M. on Sunday, April 26, 2009 through 5:00 A.M. on Monday, April 27, 2009.
- East-West on Ninth between Main and Hill Streets from 1:00 A.M. on Sunday, April 26, 2009 through 5:00 A.M. on Monday, April 27, 2009.
- East-West on Olympic between Los Angeles Street and Hill Street from 7:00 P.M. on Saturday, April 25, 2009 through 5:00 A.M. on Monday, April 27, 2009.
- East-West on Eleventh between Main and Hills Street from 7:00 P.M. on Saturday, April 25, 2009 through 5:00 A.M. on Monday, April 27, 2009.

- The following to be used as an emergency access lane around the perimeter of the event by designated event staff and City departments:
  - The westerly lane of Main Street between Ninth Street and Eleventh Street.
  - The northerly lane of Eleventh Street between Main and Hill Streets.
  - The easterly lane of Hill Street between Eleventh Street and Eighth Street.
  - The northerly lane of Eighth Street between Olive and Hill Streets.
  - The easterly lane of Olive Street between Eighth Street and Sixth Street.
  - The southerly lane of Sixth Street between Olive and Hill Streets.
  - The easterly lane of Hill Street between Sixth and Court Street.
  - Court Street between Hill and Spring Streets, and pass through lane between Broadway and Spring Streets.
  - The westerly lane of Spring Street between North Court and Ninth Street from 7:00 P.M. on Saturday, April 25, 2009 through 5:00 A.M. on Monday, April 27, 2009. Eight and Ninth Streets will remain open until 1:00 A.M. on Sunday, April 26, 2009.


I FURTHER MOVE that the Bureau of Street Services be directed to furnish the necessary traffic control devices. These devices will be provided with the understanding that the sponsoring organization will pick up and return them to the Bureau, and remove any debris following this event. Street Services is also directed to sweep the streets prior to this event, and sweep following this event, with the sponsoring organization/Event Sponsor assisting in the removal of such debris.

I FURTHER MOVE that the Bureau of Sanitation be directed to provide the appropriate number of trash containers during this event.

I FURTHER MOVE that the Department of Transportation be directed to post "Temporary No Stopping" signs and provide traffic control personnel, if necessary.

I FURTHER MOVE that the City Council authorize the Chief Legislative Analyst, or his designee, to make technical corrections or clarifications as may be necessary to implement the intent of this Motion.

I FURTHER MOVE that should unforeseen circumstances change the actual date of the Special Event, the aforementioned departmental instructions shall continue to apply.
