VERBAL MOTION

I HEREBY MOVE that Council ADOPT the recommendations of the Chief Legislative Analyst (CLA) relative to the development of the City's Transportation Strategic Plan on today's Council agenda (Item No. 25, CF 07-2655), SUBJECT TO THE APPROVAL OF THE MAYOR:

1. ENDORSE a new approach to the development of a Transportation Strategic Plan by participating in the Los Angeles Economic Development Corporation and Environmental Defense Vision Los Angeles partnership to develop and facilitate implementation of a transportation strategic plan for the Los Angeles region.
2. APPROVE the revised scope of work for the development of the City's Transportation Strategic Plan as detailed in CLA Report No. 08-04-3082 and attached to the Council file.
3. AUTHORIZE the Los Angeles Department of Transportation to submit the revised scope of work document, as detailed above in Recommendation No. 2, to the Southern California Association of Governments and further AUTHORIZE the acceptance of \$275,000 in grant funding for said purpose.

Fiscal Impact Statement: The CLA reports that approval of the above recommendations will not impact the General Fund.
