

On August 1, 2008 the City Council approved an offer of a \$75,000 reward for information leading to the identification, apprehension and conviction of the person or persons responsible for the shooting and killing of Josue Hernandez and Leonardo Ponce on July 25, 1998 and the brutal rape and death of Sigreta Hernandez on August 5, 1998 [CF#08-0010-S36]. The six month window has recently closed and the killer(s) still remain at large.
