PROPOSED AMENDMENTS TO THE LOS ANGELES MUNICIPAL CODE RELATIVE TO TRASH CHUTES AND RECYLING CHUTES

At its meeting held May 6, 2008, the Planning and Land Use Management (PLUM) Committee considered:

1. Council file No. 08-0603 - Relative to a report from the City Planning Commission (CPC), and proposed Ordinance amending Section 12.03 and 12.21 A 19 of the Los Angeles Municipal Code to define trash chutes and recycling chutes; to require recycling chutes when new or expanding projects are adding trash chutes; to remove the requirement for separate trash and recycling rooms; and to require proper identification for recycling chutes, throughout the City of Los Angeles.

The PLUM Committee approved City Planning Commission recommended actions and Ordinance, and requested the City Attorney to prepare the final draft ordinance. The PLUM Committee also considered:

2. Council file No. 06-0811 - Relative to a report and recommendations from the Department of Public Works, Bureau of Sanitation (BOS) relative to recycling chutes for multifamily and commercial buildings.

The PLUM Committee recommended that this report be received and file, inasmuch as related matters were addressed under Council file No. 08-0603.

Since both matters were also referred to the Energy and Environment Committee and the Ad Hoc on Recovering Energy, Natural Resources and Economic Benefit from Waste for L.A. (Ad Hoc on Renew L.A.) Committee, the matter is now being transmitted to Energy and Environment Committee, first, acknowledging that the Ad Hoc on Renew L.A. Committee will also have an opportunity to consider/or waive the CPC report and recommendations.
