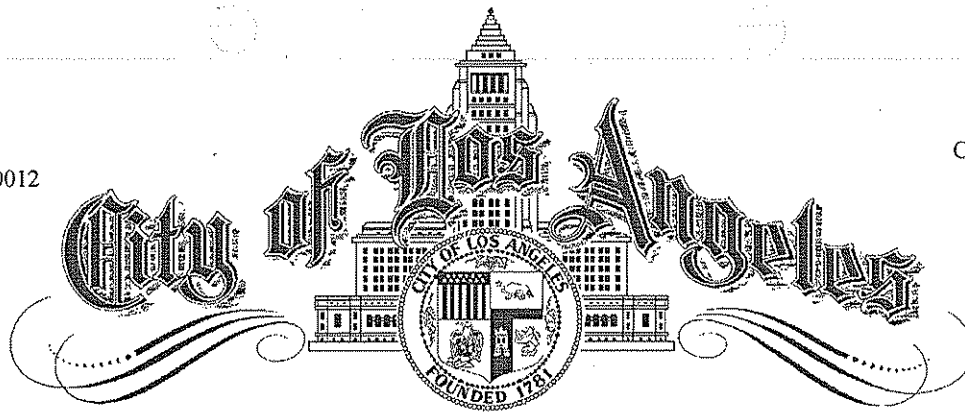

Honorable Members:

This Office recommends that discussions with, and advice from, legal counsel regarding this pending litigation be scheduled and held in closed session pursuant to California Government Code Section 54956.9(a). Government Code Section 54956.9(a) requires you to state publicly, prior to the closed session, what subdivision of this Section authorizes the closed meeting, and that the closed session is being held to confer or discuss with, or receive advice from, legal counsel regarding pending litigation.

These matters involve more than 30 separate lawsuits filed against the City by medical marijuana dispensaries, collectives, owners, operators, and patients. The lawsuits challenge the City's Medical Marijuana Ordinance on a wide variety of legal


grounds and seek to enjoin enforcement of the City's Ordinance. In limited instances, the litigants also allege unlawful "takings" of their marijuana dispensing business and seek compensatory damages against the City. Since late May 2010, this Office has defended the City against thirty separately noticed requests for temporary restraining orders and preliminary injunctions. All rulings received to date have been in favor of the City. However, the cases and related notices, briefing schedules, hearings, and judicial decisions will continue.

We request that this matter be placed on the closed session portion of the City Council's agenda of Wednesday, August 11, 2010.
