TRANSPORTATION COMMITTEE REPORT relative to the status of the proposed on-street car share pilot program.

Recommendations for Council action:

1. DIRECT the Los Angeles Department of Transportation (LADOT) to report back to the Transportation Committee in 120 days with an update report on the pilot program and more detailed recommendations.
2. INSTRUCT the LADOT to continue coordination efforts with City Planning and the Metropolitan Transit Authority.
3. DIRECT the LADOT to explore whether program costs could be moved to the Special Parking Revenue Fund, Proposition C Fund, or Proposition A Fund.

Fiscal Impact Statement: None submitted by the LADOT. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis on this report.

Community Impact Statement: None submitted.

SUMMARY

At a special meeting held on January 27, 2010, the Transportation Committee considered the LADOT report relative to the status of the proposed on-street car share pilot program. Representatives from the LADOT and Zipcar, Inc. gave the Committee background information on the matter. An opportunity for public comment was held. Afterwards, the Committee moved to approve the recommendation contained in the report, instructed the LADOT to continue coordination efforts and explore whether program costs could be moved to the Special Parking Revenue Fund, Proposition C Fund, or Proposition A Fund. This matter is now forwarded to the Council for its consideration.
