Your **TRANSPORTATION** Committee

report as follows:

TRANSPORTATION COMMITTEE REPORT and ORDINANCE relative to amending the Los Angeles Municipal Code (LAMC) to authorize and establish a car share vehicle program in the City of Los Angeles.

Recommendation for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

ADOPT the accompanying ORDINANCE amending the LAMC to add a new Section 80.58.1 and amend Sections 80.76.2 and 89.60 of Chapter VIII to authorize and establish a car share vehicle program in the City of Los Angeles.

Fiscal Impact Statement: None submitted by the City Attorney. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis on this report.

Community Impact Statement: None submitted.

SUMMARY

In a report dated February 11, 2009, the City Attorney submitted for Council consideration an ordinance that adds a new Section 80.58.1 and amends Sections 80.76.2 and 89.60 of Chapter VIII of the LAMC to authorize and establish a Car Share Vehicle Program in the City of Los Angeles. The draft ordinance was presented in response to the Council's on-going support for such a program and in response to the enactment by the California State Legislature of California Vehicle Code Section 22507.1, at the City's behest, which now provides the legislative authorization for local car share vehicle programs.

At a regular meeting held on February 25, 2009, the Transportation Committee considered the ordinance to authorize and establish a car share vehicle program in the City of Los Angeles. Representatives from the City Attorney's Office and the Los Angeles Department of Transportation gave the Committee background information on the matter. An opportunity for public comment was held. Afterwards, the Committee moved to approve the ordinance to establish a car share vehicle program in the City. This matter is now forwarded to the Council for its consideration.
