At its regular meeting held March 12, 2013, the Mar Vista Community Council approved the following Policy Motion on removal of illegal digital billboards:

The MVCC Board urges the City of Los Angeles to fully implement the appeals court ruling in the Summit Media LLC v. City of Los Angeles and to remove the 103 illegal digital billboards blanketing our city. We further request that the City refrain from making any changes to the zoning laws relative to digital billboards until the illegal boards are removed and any such proposed change has been subjected to an open and transparent outreach process to community stakeholders.
