Honorable Members of the P.L.U.M. Committee,

In an attempt to deal with the Citywide blight of abandoned shopping carts, Councilmember Tony Cardenas and Councilmember Greig Smith co-presented a Motion to City Council on August 6, 2008 asking that the Planning Department, with the assistance of the City Attorney, be directed to prepare and present a Citywide Ordinance within 30 days that would be similar to one enacted in the City of Glendale which regulates the proliferation of abandoned shopping carts through the land-use process. The Motion was referred to City Council's Planning and Land-Use Management Committee on August 6, 2008. Today is the 28th of December, long past the requested 30 days noted in the Motion and there has been no further action since the date of referral.
