Meeting called to order at 7-15 pm—

Special introduction - Mr. Tom Griego, City Attorney, City of Los Angeles

seated with panel to provide special counsel on "issues and procedures in front of the board".

FIRST PUBLIC COMMENT —

Due to the fact that the proponents of the Van Nuys area name change had already given an extensive presentation at a prior VNNC meeting—A five (5) minute block of time reserved for "Van Nuys area name change"; proponents divided up time and were allowed an additional three (3) minutes total of eight (8) minutes. Four speakers total for name change. 2 speakers total against allowing the area to change name.

VNNC STANDING RULES - clarification "Abstention Votes"

President Mather — relating as to a previous vote in controversy; "an abstention is a non vote, as if the member casting it was absent." To clarify, the President "polled" all members present who agreed, individually, with the common standard for what an abstention vote is.

SECRETARY's REPORT — Minutes distributed by E-Mail. Previous interpretation resolved. Motion to accept passes without objection.

TREASURER's REPORT — current budget distributed, \$80, 381 available, \$46.000 remaining. Budget moved for acceptance unanimously (except for Ock, minor student, abstaining).

SPECIAL GUESTS —

Tamar Galatzan, Neighborhood Prosecutor. Discussed continuing concerns - illegal vendors, a joint task force at Jon's, foreclosed properties, squatters, even people renting out foreclosed homes to others.

NEW BUSINESS —

Van Nuys Name Change (the area south of MTA Orange Line)

President Mather reads 2 letters into record--

- from Keyes Motors, 5800 blk Van Nuys Bl opposing change as major Van Nuys business
- from Sherman Oaks NC President Jill Banks Barad re SONC's position to not "accept" south of Orange Line residents by a vote of — 10 against; I for; 3 abstain

Solomon makes motion to oppose "Van Nuys name change". Discussion — Mather closes with the importance of maintaining our demographic and census track, to combat negativity about Van Nuys, revitalize Van Nuys Blvd, and unify community through pride and good works. City Attorney Griego notes that questions regarding VNNC board members "voting" who live in the proposed "breakaway zone" were clarified; they may vote. Call for the question — members "polled" by seat order. For motion to oppose the "name change"; (13) Ock, Hendry, Ortiz, Jacobs, Mather, DuVall, Solomon, Feigenbaum, Meyer, Arrevalo, Vescovo, Cordaro, Weimer — in favor of "name change"; 4) Ciccarelli, Nunez, Marez, Thornton-Davis Motion carries--5 minute recess while "name change supporters" leave.

Second motion regarding "Van Nuys name change" Solomon moves to transmit VNNC's vote to City Clerk, to CD 2, 6, and to prepare a CIS (Community Impact Statement) with VNNC's position. VOTE; 15 aye—unanimous

Outreach — Solomon moves to spend or VNNC promotional materials -\$1050 for note pads and \$800 for "I Love VN" buttons. Mather suggests revised appropriation, due to City's budgeting problems, simply budget additional \$4,000 for large "cross boulevard" banners. Solomon then revises to add \$2,000 for tote bags **VOTE: motion carries, I4 aye, (Ock abstains)**

2009 Funding of Music, Christmas, Farmers' Market

Motion to put \$12,000 into long-range funding- Items, events, funding to be augmented later.

VOTE: motion carries, I4 aye, (Ock abstains)

SPECIAL GUESTS (second open period)

Frank Banos, CD 6 Cardenas, to offer "Cash for College" event, 2/7/09, 9-12 am (call office) Grants up to \$1,000 will be made. Offers interest to work closely with VNNC on "XMAS on VN Blvd.", some members question him as to making event "bigger". **Taneda Larios,** DONE--- Special DONE event at Braude, 1/24/09, with City's Director of Transportation. Working towards a MOU with NC's on traffic issues. Additional discussion will be offered on new ways to fund NC's. In addition, for all, do the "Ethics" workshop (possibly a "live Ethics presentation" in lieu of the test, but not before Feb). Request that VNNC do "electronic bylaws" for DONE. MEMBERS, PLEASE DO MAYOR's BUDGET SURVEY.
