As you know the American Federation of State, County, and Municipal Employees ("AFSCME") represents the Basic, Supervisory, Professional, and Management bargaining units (Locals 164, 585, 1890, and 2204) at the Community Redevelopment Agency of Los Angeles ("CRA/LA"). We have appreciated the recognition that the City has given us over the years in praising our efforts.

On Wednesday, you will consider approving the establishment of a new Economic Development Department - functions previously performed by CRA/LA. We ask as you do so that you take the following steps:

- 1. Ensure the organization is a public entity
- 2. Hire qualified CRA/LA employees prior to considering other outside candidates (now and in the future)
- 3. Honor each hired CRA/LA employee's seniority

We must make sure the organization is accountable and functions in a way that engenders the public trust. Private non-profit models in San Diego and elsewhere have resulted in Grand Jury indictments, firing of CEO's who make improper payments to themselves and others, and worse...

Furthermore, we believe that you are legally obligated to hire the CRA/LA staff and the City is receiving additional property tax revenue due to the dissolution of the CRA/LA.

Taking these steps will not only add to the talent of the City, but also support the new obligations the City is assuming – all while treating the former CRA/LA employees with the respect they deserve.
