The City Council ADOPTED the following recommendation(s) contained in a COMMUNICATION FROM THE BOARD OF POLICE COMMISSIONERS which were WAIVED, pursuant to Council Rule 17, by the Chair of the Public Safety Committee, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. APPROVE payment to claimant of a reward offer in the amount of \$50,000 for information leading to the arrest and conviction of the suspects responsible for the shooting death of Mr. Noe Gonzalez on October 1, 2008.
2. INSTRUCT the City Clerk to:
 - a. Transfer \$50,000 from the Reserve Fund to the Unappropriated Balance and appropriate therefrom to the Special Reward Trust Fund No. 436/14.
 - b. Transfer \$50,000 from the Special Reward Trust Fund No. 436/14, Account No. XXXXXX to the Police Department Fund No. 100/70, Secret Service Account No. 004310.
3. INSTRUCT the Los Angeles Police Department to make the appropriate reward payment.
