An ordinance amending Subsection (b) of Section 22.210.2, Chapter 10, Article 4 of the Los Angeles Administrative Code, Schedule of Charges for Emergency Services to increase the Advanced and Basic Life Support Services response call fees.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. Subsection (b) of Section 22.210.2 of the Los Angeles Administrative Code is amended to read as follows:


(b) **Schedule of Charges for Emergency Service.**

| EMERGENCY AMBULANCE SERVICE RENDERED BY CITY PERSONNEL | CHARGES |
|---|------------|
| Basic Life Support Fee, Each Patient | \$974.00 |
| Advanced Life Support Fee, Each Patient | \$1,373.00 |
| Mileage One Way – Per Mile | \$15.75 |


Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
