RESOLUTION

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations or policies proposed to or pending before, a local, state or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, the California Vehicle Code and various administrative regulations establish the methodology for local governments to set speed limits on local streets; and

WHEREAS, the California Vehicle Code specifies that, in order to use radar or any other electronic device to enforce speed limits, a speed limit must be justified by an engineering and traffic survey; and

WHEREAS, traffic enforcement agencies that try to address speeding on roadways are restricted by existing regulations that requires speed limits not be set any lower than the actual speed of 85% of the vehicles traveling on a specific street;

WHEREAS, this restriction, adopted to prevent municipalities from implementing unreasonable speed limits and setting up so-called "speed traps," helps ensure that high-speed streets are a self-fulfilling prophecy; and

WHEREAS, cities continually struggle with providing a delicate balance of efficiently moving vehicles, supporting bicycling and pedestrian activities and preserving community character; and

WHEREAS, the California Traffic Control Devices Committee (CTCDC) has proposed administrative changes to allow some flexibility in establishing a speed limit on public roadways and other possible alternatives; and

WHEREAS, the CTCDC will hold a special hearing on February 24, 2009 to review the on-going issue of speed limit-setting in local communities, and under what circumstances speed limits can be altered to address local safety concerns;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2009-10 State Legislative Program SUPPORT and/or SPONSORSHIP of legislation and/or administrative changes that would provide more flexibility in the establishment of speed limits in local jurisdictions.
