#### STATUS OF LIABILITY ACCOUNTS

Honorable Members:

The City Attorney's Office has been asked to periodically report to your Committee on the status of liability payouts from the General Fund liability accounts 9760 and 9770. In addition, we have been asked to identify pending cases that have a substantial likelihood of being resolved during fiscal year 2009-2010 which could require payments over \$100,000 from the General Fund.

For fiscal year 2009-2010, the Adopted Budget appropriated \$10 million for Account 9760 and \$31 million for Account 9770. In addition, Council authorized a transfer of \$1.9 million from the Solid Waste Resources Revenue Fund for a settlement involving a Sanitation trash truck.
