Meeting called to order at 07:15 PM.

 - Mr. Legassie announced that \$20,000 in encumbered funds (17 open projects) are in jeopardy, depending on budget decisions to be made by the City.

Mr. Legassie requested that the Treasurer's report be approved. So moved by Joseph Riser, seconded by Paula Sirola. Motion approved: 13 in favor; 0 opposed; 0 abstentions.

 - 2. <u>BUDGET REVISION</u> Revision of budget from \$52,000 back to \$45,000 based on DONE's Jan 2010 decision not to accept any budget changes pending a review of rollover and NC fund balances. Also discussion of impact and possible transfers from other budget categories to partially cover the loss.

Joseph Riser moved to transfer \$1500 from local issues and \$2000 from stakeholder communications to go to community projects. Seconded. Passed 8 yes, 0 no, 1 abstaining.

Brief Summary: The ASNC opposes the combined impact of this motion, which repossesses an average \$18,000 per council in critical rollover funds while also slashing 2010-11 allocations by half. This immediate, effective loss of nearly \$40,000 per council (leaving less than \$25,000 next year), makes the "shared sacrifice" for certified councils so much greater than that of most City entities -- including some not even mandated by the voter-approved City Charter.

It includes \$1.6 million from past years, much of which may be encumbered by promises made by neighborhood councils as City entities, as well as half of the current per-council allocation rate of \$45,000. The combined takebacks and future cuts will result in an effective removal of nearly two-thirds of the funds available to councils, compared to the pre-2009 allocations, and make the neighborhood council system's "shared sacrifice" under L.A.'s current budget crisis several times the "share" being taken from any other City function.
