
MOTION


On May 1, 2009, the City Council authorized the expenditure of \$130,000 in settlement in the case entitled Mary Cummins-Cobb v. City of Los Angeles, et al., Los Angeles Superior Court Case No. BC374596 (Council File No. 09-0704). Recommendation No. 2 authorized the City Attorney to draw a demand thereon in said amount payable to the Law Offices of Rheuban and Gresen Client Trust Account.

Plaintiff Mary Cummins-Cobb's attorney, The Law Offices of Rheuban and Gresen, subsequently has made a request that the \$130,000 settlement payment be made in the form of two separate demands payable to the plaintiff and her counsel.

I THEREFORE MOVE that the Council, subject to the approval of the Mayor, amend its action of May 1, 2009 (C.F. 09-0704) and substitute the following recommendation for Recommendation No. 2, relative to the settlement in the case entitled Mary Cummins-Cobb v. City of Los Angeles, et al. as referenced above:

- 2. AUTHORIZE the City Attorney to draw two demands thereon as follows: \$52,000 payable to the Law Offices of Rheuban and Gresen; and, \$78,000 payable to Mary Cummins-Cobb.
