PLANNING AND LAND USE MANAGEMENT COMMITTEE REPORT relative to establishing immediate full Cost Allocation Plan recovery on Department of City Planning (DCP) entitlement requests.

Recommendation for Council action, pursuant to Motion (Koretz - Reyes):

DIRECT the DCP and the City administrative Officer, with the assistance of the City Attorney, to report to the Planning and Land Use Management Committee and the Budget and Finance Committee with a draft ordinance establishing immediate full Cost Allocation Plan recovery on DCP entitlement requests.

<u>Fiscal Impact Statement</u>: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

(The Budget and Finance Committee waived consideration of this matter.)

Summary:

At a public hearing held on April 27, 2010, the Planning and Land Use Management (PLUM) Committee considered Motion (Koretz - Reyes) relative to directing the DCP and the City administrative Officer, with the assistance of the City Attorney, to report to the Planning and Land Use Management Committee and the Budget and Finance Committee with a draft ordinance establishing immediate full Cost Allocation Plan (CAP) recovery on DCP entitlement requests. This matter was considered along with a DCP report attached to Council file No. 09-0600-S50 relative to a proposed ordinance to include a portion of the City overhead rate. During the discussion of this matter, testimony was heard from the Deputy Director of Planning relative to the DCP report and from a representative for Councilmember Koretz relative to the Motion (Koretz - Reyes). After an opportunity for public comment, the PLUM Committee recommended that Council approve the Motion. This matter is now forwarded to Council for its consideration.
