#### Question #2 – What did you like about your Neighborhood Election process?

- It was very organized and professional.
- Friendly staff and helpful.

#### Question #3 - What did you not like about your Neighborhood Election process?

- Lack of election awareness (little notification ahead of time).
- Not enough candidates, no candidate statements visible.
- Write in section confusing.
- I would like city wide publicity for the election.
- On ballot confused when writing in only candidate and fill in too. Write-in's on wall should be more viewable.

- I would have liked to know more about the positions/platforms of the candidates.
- The lack of publicity and forehand information.
- There were people campaigning in the parking lot.
- People handing out flyers of who to vote for outside! Electioneering?
- More clarity at the outset, some larger outreach/education that explains who we are able to vote for.
- Voting on a Saturday
- Lack of publicity/notification. Lobbying in the parking lot.
- I think stakeholders needed more information prior to Election Day to remind/educate them on all the categories and ID that would be required.
- Not all the candidates had statement

- I did not like the candidates asking for my vote as I passed them in the parking lot.

- Was unsure as to who/what I could vote for didn't think to bring my property tax statement to prove ownership. Would have liked the opportunity to know more about the candidates although the GHSNC emails help a great deal.
- Would like more info on all candidates.
- No info on candidates.
- The City Clerk's office and personnel.
