If a candidate seeking multiple Board positions on one NC Board is declared the winning candidate for more than one of those positions, the candidate will be required to vacate all except one Board position no more than three days from the day the elections are certified or from the day when any and all election recounts and challenges are resolved for the specific NC election, whichever date is later. These vacated positions shall be filled with the remaining candidate who received the most votes, or if none, via the vacancy clause identified in this 2010 NC Election Procedures Stipulation Language Worksheet.

Accordingly, in the event a candidate should win multiple seats, the process for vacating shall be:

- The candidate will choose which one (1) seat s/he wishes to be seated-in.
- The candidate must file a Notice of Vacating Candidacy for Multiple Positions on a Board Form (issued by the City Clerk) by the deadline 1.





- Vice President Vote for one (1)
- Treasurer Vote for one (1)
- Secretary Vote for one (1)
- Sergeant-At-Arms Vote for one (1)
- Business Representative Vote for one (1)
- Education Representative Vote for one (1)
- Youth Representative Vote for one (1)
- Senior Representative Vote for one (1)

Summary:

- The NC has 9 Board seats. All **9** are elected.
- Stakeholders will use **Self-Affirmation** as a means of establishing their stakeholder status.
- Minimum stakeholder voting age is 12.
- The NC Board has a two-year term.
- Candidates can run for no more than one Board seat.

- 8. You shall not engage in negative campaigning ("mudslinging") during your campaign.

- 11. You may ask questions about election procedure and observe the election process.
- 12. You may report any illegal or fraudulent activity to the City Clerk Election Division.

Election Date: Tuesday, March 2, 2010 Challenge Item No.:1A

Challenger: Eric Rosenberg

Neighborhood Council: Granada Hills North Neighborhood Council (GHNNC)

Allotted Discussion Time: 20 Minutes

CHALLENGE (State the challenge and requested remedy verbatim - do not interpret or restate them.)

Challenge:

Rahim Kazi, a candidate who ran for and won the District Two seat, is not eligible for holding that seat on the Board per GHNNC's current bylaws (approved by DONE/BONC in 2009).

Proposed Remedy:

That the candidacy of Rahim Kazi be nullified, and that a new election be held with only eligible candidates running for the respective available seats, and that the City Clerk abide by the bylaws approved by BONC/DONE.

FINDINGS (Based on your investigation, what you have been able to determine. Only speak to the issues in these challenges and not how to resolve them in future elections.)

The Office of the City Clerk – Election Division developed Policy No. 10, which states, "Any Department of Neighborhood Empowerment (DONE) approved bylaws received by the City Clerk – Election Division after 5:00 p.m. of June 1, 2009, will not be applied to the 2010 Neighborhood Council Elections." The Department of Neighborhood Empowerment (DONE) submitted bylaws on GHHNC's behalf by the stated deadline (See Attachment A). These bylaws (dated May 2009) defined stakeholders as those who, "live, work or own property within the neighborhood and affirmed a factual basis for it." (GHNNC May 2009 Bylaws, Article 5).

The GHNNC Board submitted their Stipulation Language Worksheet May 4, 2009 (See Attachment B). In Section 9, Governing Board and Composition, GHNNC states that District Two Stakeholders qualify to run and vote for the District Two seat.

On October 26, 2009, Project Coordinator Sofia Torres presented the Draft Election Procedures to the GHNNC Board. During the presentation, Ms. Torres requested that the Board contact her if any corrections needed to be made to the document no later than 130 days prior to their Election Day. Thereafter, a few boardmembers clarified areas that needed corrections. Corrections were made to the qualifications to run and vote for the Student Representative Seat and clarification regarding the council district GHNNC represented. These changes were made to the document and posted on the City Clerk's website at the inception of candidate filing (See Attachment C).

On December 12, 2009, Rahim Kazi attended the Region A Stakeholder Candidate Filing Informational Meeting. Mr. Kazi submitted a Candidate Filing Form which expressed his interest in running as a District Three Representative (See Attachment D). Mr. Kazi's address did not fall within District Three but did fall within the District Two boundaries. Mr. Kazi was contacted and informed of this and as a result accepted the change of his candidacy from District Three to District Two.

In January 2010, Ms. Torres was contacted by Sue DeVandry. Mrs. DeVandry contended that Mr. Kazi shouldn't be allowed to run as the District Two Representative because he was a resident and not a business owner. Ms. Torres researched the matter and concluded that the May 2009 bylaws did not prohibit Mr. Kazi from running as a District Two candidate. Ms. Torres contacted Mrs. DeVandry and informed her of the findings.

On January 19, 2010, Eric Rosenberg emailed Ms. Torres and expressed the same objection to Mr. Kazi's candidacy and cited GHNNC's September 2009 bylaws (See Attachment E). Mr. Rosenberg was informed that the Office of the City Clerk did not use bylaws that had been amended after the June 1, 2009 deadline. Mr. Rosenberg requested that the Office of the City Attorney review this issue and provide their opinion regarding the matter. On January 27, Deputy City Attorney Darren Martinez rendered his opinion and agreed with the City Clerk's position. Mr. Martinez mentioned that although the Board's intent was to require residential or worker candidates within District One and Two to run as District Three candidates, the bylaws never explicitly state this.

RECOMMENDATION (Your recommendation as to how to ameliorate the issues that have been substantiated. No policy recommendations for future elections should be included in this section.)

The Office of the City Clerk recommends that the GHNNC amend their bylaws to clearly reflect what their intent is on stakeholder's eligibility to run and vote for all seats. If the Board wants to restrict certain stakeholders from running for particular seats, they must detail these restrictions in their bylaws.

Mr. Kazi should remain the District Two Representative until the next scheduled election in 2012 when all board seat qualifications are detailed in GHNNC's amended bylaws.

Challenge:

Steven Leffert was ineligible to be a candidate for the Organizational Stakeholder Representative (OSR) position. Mr. Leffert filed as an "authorized representative of UTLA." However, the submitted membership card indicates that he is a "retired life member" and his candidate statement states that he is a "retired teacher."

Proposed Remedy:

Declare Steve Leffert ineligible as OSR candidate and disqualify him from taking office in this position.

The Office of the City Clerk - Election Division developed the Lake Balboa Election Procedures using the certified bylaws for the Lake Balboa Neighborhood Council (See Attachment A). On Attachment B of the Election Procedures (See Attachment B), the qualifications to run for the Organizational Stakeholder Representative position is as follows, "any stakeholders who participate in a religious institution, educational institution, community organization, non-profit organization, neighborhood association, school/parent group, faith based group, senior group, youth group, arts association, service organization, boys and girls club, cultural group, or environmental group within the Council's boundaries who is 18 years or older.

Mr. Leffert submitted a membership card indicating that he is a retired life member and a signed letter from A.J. Duffy, UTLA President (Attachment C) attesting to the fact Mr.

Leffert is "authorized to represent UTLA," thus qualifying him as a participating member of an educational institution.

RECOMMENDATION (Your recommendation as to how to ameliorate the issues that have been substantiated. No policy recommendations for future elections should be included in this section.)

The Office of the City Clerk recommends that the Panel dismiss this challenge based on the supporting documentation Mr. Leffert submitted to our office.

Challenger: Stephen Edwin Knight

Neighborhood Council: Del Rey Neighborhood Council (DRNC)

CHALLENGE (State the challenge and requested remedy verbatim - do not interpret or restate them.)

Challenge:

The DRNC Election ran out of ballots for Area G for a period of approximately one and one-half to two hours.

Proposed Remedy:

Hold a Special Election for Area G stakeholders in the center of Area G. The center of Area G is the Mar Vista Gardens Housing Center.

FINDINGS (Based on your investigation, what you have been able to determine. Only speak to the issues in these challenges and not how to resolve them in future elections.)

On Sunday, April 11, 2010, the City Clerk held the DRNC Election from 12:00 p.m. to 6:00 p.m. Kristine Flores, Inspector for the election, called Election Central (ECentral) to request more ballots. ECentral is the Election Day problem-solving headquarters that provides assistance and material support to pollworkers throughout Election Day. For each Regional Election Day, the Office of the City Clerk - Election Division makes available a hotline for pollworkers to call and report problems, request supplies or more pollworkers. Additionally, the Election Division will deploy roving Supervisors and have two re-supply trucks stationed in the field.

At approximately 2:20 p.m., the Inspector requested the delivery of additional Area G Ballots. At that time, there were 20 of the original 50 ballots issued left at the polling place. Based on the voter turnout of previous DRNC elections, the City Clerk projected a low voter turnout (See Attachment A) and printed 50 ballots for the Area ballots and 200 for the DRNC Ballot which is the factual basis stakeholder ballot. Approximately an hour after the initial call was made to ECentral, Area G Ballots were delivered to the polling location. Three voters had waited about 30 minutes before the Area G Ballots arrived and they were able to vote. Two voters (mother and daughter) could not wait for

the ballots to be delivered due to work. The Inspector informed these individuals that she would contact them once the Area G Ballots had been received. ECentral dispatched City personnel to provide the two individuals who had left with an opportunity to vote in curbside voting (See Attachment B). The Inspector was able to contact one of the voters (mother) who returned to the polling location to vote. However, she was not able to reach the daughter. Due to the special circumstances, a Vote-By-Mail (VBM) Ballot and envelope were issued to the mother to give to her daughter. The following day, various attempts were made to reach the voter to coordinate and schedule a pick up of the VBM ballot; messages were left on her voicemail, but neither the Inspector nor the Service Center Staff designated to pick up the ballot were able to contact the voter.

RECOMMENDATION (Your recommendation as to how to ameliorate the issues that have been substantiated. No policy recommendations for future elections should be included in this section.)

The Office of the City Clerk recommends that the challenge be dismissed as the matter was rectified by providing the two stakeholders with the opportunity to vote. Corrective action was taken by delivering the Area G Ballots in a timely manner and providing accommodations for the two voters, as an administrative solution. Furthermore, the Area G Ballot contained seven Officer seats and one Area Director seat with five of the eight seats being uncontested (See Attachment C). In this particular case, the margin between the candidates for the contested seats was too great for one vote to make a significant difference to the outcome of the election (See Attachment D). Therefore, the City Clerk recommends that no further action be taken.

Challenger: Sieglinde "Ziggy" Kruse

Neighborhood Council: Hollywood Studio District (HSDNC)

CHALLENGE (State the challenge and requested remedy verbatim - do not interpret or restate them.)

The challenge states "[m]isleading information (a slate that included HSDNC Logo) was handed out at the polling place location by various board members, including the Chair of the Hollywood Studio District Neighborhood Council."

The requested remedies are to add the additional candidates listed on the "unofficial election results" to the board as elected board members or redo the entire election based on the misleading slate and ensure that no logo will be used in that election.

Please note that an accompanying challenge was also submitted, but was not accepted for review as it addressed items deemed not challengeable under City Clerk - Election Division Policy No. 29.

FINDINGS (Based on your investigation, what you have been able to determine. Only speak to the issues in these challenges and not how to resolve them in future elections.)

According to the challenge, a flyer was handed out to voters during the election that had the HSDNC designation on it (see Attachment A). The HSDNC polling place staff confirmed that voters were given this flyer outside of the 100-foot electioneering boundary and that versions were also made available to voters in Spanish and Armenian (see Attachment B).

According to Article XII, Section A of the 2010 HSDNC Election Procedures, "[t]he use of the City of Los Angeles Seal, the Office of the City Clerk Seal, the Election Division Logo, the Department of Neighborhood Empowerment Logo or any other official Neighborhood Council (NC) designation created by the Department of Neighborhood Empowerment is prohibited for use on candidate materials" (see Attachment C). The 2010 HSDNC Election Procedures do not state whether the use of all or part of a designation or logo on candidate materials is sufficient to constitute a violation of the procedures. However, the overall purpose of this provision is to prevent candidates

from campaigning under the expressed or implied endorsement or authorization of the City or NC.

The flyer in question contains information about the place, date and time of the election, as well as a sample ballot of the slate of candidates seeking election. At the top of the flyer, the name "Hollywood Studio District Neighborhood Council" appears in the same distinct style, size, and font that the HSDNC uses as part of its logo (see Attachment A). The HSDNC logo, in addition to the name of the NC, also contains a silhouette of a cameraman (see Attachment D).

According to the HSDNC Parliamentarian, the flyer in question was produced by the current HSDNC Chair, Maripat Donovan (see Attachment E). About 50-60 flyers were produced and it is estimated that 50 were handed out to voters on Election Day. During production, the cameraman was purposefully deleted to comply with Article XII, Section A of the 2010 HSDNC Election Procedures, but the rest of the logo was left intact. According to the Parliamentarian, the silhouette of the cameraman is the focal point of the HSDNC logo and that any use of the logo by the NC always incorporates the cameraman with the lettering (see Attachment F).

The candidates promoted by this slate were contacted via email for their input on this flyer. Of those that responded, all but one were aware that part of the logo was used, but contend that its use did not violate provisions of the 2010 HSDNC Election Procedures (see Attachment G).

The 2010 HSDNC Election Procedures clearly state that a designation used by a NC may not be used on candidate materials. In this instance, the logo "Hollywood Studio District Neighborhood Council" was purposefully used for a flyer to promote a slate of candidates. Although the silhouette of the cameraman was not used for the flyer, a significant and distinctive part of the logo was utilized to aid a select group of candidates.

RECOMMENDATION (Your recommendation as to how to ameliorate the issues that have been substantiated. No policy recommendations for future elections should be included in this section.)

The challenger has requested two remedies. The first requested remedy is to disqualify the slate candidates and award the other non-slate candidates the contested seats. The second requested remedy is to redo the entire election and ensure that no logo will be used in that election.

In regard to the latter remedy, the City Clerk believes that this is disproportionate to the violation of the 2010 HSNDC Election Procedures. Although a NC resource was improperly used, its use does not warrant the negation of the entire election.

Rather, the City Clerk believes that disqualification of all eight candidates affiliated with the slate promoted by the flyer is a proper remedy and that the next highest vote getter(s) be awarded the seats or, if none, the HSDNC's vacancy clause is enacted. The eight candidates affiliated with the slate promoted by the flyer include: At-Large Governors P. Jennifer Christie Jenny R. Weatherholtz Edward V. Hunt Nathan A. French Anna Gyumushyan Owner-Occupied Residential Property Owners Governors Darren R. 2010 EAST HOLLYWOOD NEIGHBORHOOD COUNCIL (EHNC) ELECTION – FINAL CHALLENGE RESULTS

Dear EHNC Board Members,

On April 7, 2010, the Office of the City Clerk - Election Division (City Clerk) received an Election Challenge Application for the East Hollywood Neighborhood Council (EHNC) in which David Uebersax, an EHNC Stakeholder, challenged candidate-elect Sam Kbushyan for alleged misuse of City and Neighborhood Council (NC) logos.

After investigating the matter, the City Clerk compiled a report determining that Mr. Kbushyan, an EHCN candidate, sent an email in his personal capacity recommending that certain board members should be elected for the Greater Griffith Park Neighborhood Council and also included a flyer with his email that was prepared by the EHNC reminding voters of its March 20, 2010, election. Although Mr. Kbushyan forwarded an EHNC flyer that contained a City logo and City seal, Mr. Kbushyan did not use a Neighborhood Council logo or City seal on his personal campaign materials but merely forwarded an authorized flyer that had been prepared by EHNC. The forwarding of authorized flyers does not constitute a violation of the City's Election Procedures. Accordingly, the City Clerk recommended to the Neighborhood Council Election Challenge Panel (Panel) that the challenge should be dismissed and Mr. Kbushyan should remain the Business Representative until the next election.

The City Clerk's report was reviewed by the Panel on May 15, 2010 (See attached). The Panel, which is composed of two Neighborhood Council stakeholders and one City Commissioner ruled against the City Clerk's recommendation and instead voted for an alternate sanction. By unanimous vote, the Panel choose sanction #2 in the category of, "Use of City Agencies and NC Logo by Candidates", which reads, "[i]f the Candidate is found to have used the logo(s) of any

City agency or NC for campaign purposes, then disqualify the Candidate(s) (next highest vote getter, if none, vacancy clause enacted) and send a letter of determination to the Board, Challenger and Candidate(s)."

However, the City Clerk has determined that the Panel's decision was clearly erroneous. Therefore, the Panel's decision will be reversed. Ordinarily, under the City Clerk's Election Procedures, the Panel's decision would be final. However, the City Clerk has the authority to override a Panel's decision when there is an insufficient factual basis to support the Panel's decision or the uncontroverted facts fail to demonstrate a violation of the spirit and intent of a specific election procedure. Under Administrative Code section 22.816, the City Clerk may administer all aspects of the Neighborhood Council elections, including issuing directives and policies to preserve the integrity of the Neighborhood Council election process. Therefore, the City Clerk's recommendation will stand and Mr. Kbushyan will remain the Business Representative until the next election. Accordingly, the City Clerk will notify Mr. Uebersax and Mr. Kbushyan of the revised decision.

The City Clerk's decision is final. The challenge, along with the City Clerk's recommendation and the City Clerk's final decision will be posted on our website by Thursday, May 27, 2010. All Election Challenges for EHNC have been resolved. Accordingly, the NC is now free to seat the newly-elected board in accordance with City Clerk - Election Division Policy No. 22.

Reminder notice sent included logos for the Neighborhood Council (NC) and the City of Los Angeles.

Proposed Remedy:

Disqualification of candidate as elected to Business Representative Position and/or a restriction from the ability to serve on NC Boards in the future.

FINDINGS (Based on your investigation, what you have been able to determine. Only speak to the issues in these challenges and not how to resolve them in future elections.)

On Friday, March 19, 2010, Sam Kbushyan sent an email to stakeholders and attached an email with a reminder notice to vote in the EHNC election which included the NC logo, name of NC, location, date and time of the election (See Attachment A).

Article XII, Section A of the EHNC Election Procedures prohibits candidates from using the City of Los Angeles Seal, the Office of the City Clerk Seal, the Election Division Logo, the Department of Neighborhood Empowerment Logo or any other official Neighborhood Council designation created by the Department of Neighborhood Empowerment on candidate materials (See Attachment B).

According to Article XIX, Section A of the EHNC Election Procedures, a Neighborhood Council is responsible for informing stakeholders about the election. Based on the evidence provided in Attachment A, it appears that Mr. Kbushyan forwarded the reminder email that was initially issued by the EHNC, acting in its official capacity to outreach and inform the community about the election.

Sam Kbushyan has not violated any election campaigning procedures by using the NC logo and the City of Los Angeles Seal because it was the EHNC Board that initially sent out the reminder notification.

RECOMMENDATION (Your recommendation as to how to ameliorate the issues that have been substantiated. No policy recommendations for future elections should be included in this section.)

The Office of the City Clerk recommends that the challenge be dismissed as the candidate has adhered to the guidelines on the EHNC Election Procedures. Furthermore, Mr. Kbushyan should remain the Business Representative until the next scheduled election.

On April 6, 2010, the Office of the City Clerk - Election Division (City Clerk) received an Election Challenge Application for the GEPENC in which Lucio Aguirre Fernandez, a GEPENC Stakeholder, challenged candidate-elect Jose Sigala for alleged electioneering at the polling place on Election Day.

After investigating the matter, the City Clerk compiled a report including a recommendation stating that the challenge be dismissed. The City Clerk's recommendation stated that Mr. Sigala and other candidates complied with City Clerk - Election Division Policy No. 5. The full report was reviewed by a Neighborhood Council Election Challenge Review Panel (the Panel) (see attached). The Panel, composed of two Neighborhood Council stakeholders and one City Commissioner, is tasked with making the final ruling on each Election Challenge.

The Panel's final decision was to dismiss the challenge. Therefore, candidate-elect Jose Sigala should be allowed to take the Board Seat for which he was elected on March 20, 2010. Additionally, the City Clerk will notify Mr. Fernandez and Mr. Sigala of the Panel's decision.

All decisions made by the Panel are considered final. The challenge, along with the City Clerk's recommendation and the Panel's final decision will be posted on our website by Thursday, May 27, 2010. All Election Challenges for GEPENC have been resolved. Accordingly, the NC is now free to seat the newly-elected board in accordance with City Clerk - Election Division Policy No. 22.

CHALLENGE (State the challenge and requested remedy verbatim - do not interpret or restate them.)

Mr. Jose Sigala was electioneering on the northwest and southeast corner of where Boston Street intersects Edgeware Road.

Remedy Requested:

To disqualify Mr. Sigala due to Electioneering.

FINDINGS (Based on your investigation, what you have been able to determine. Only speak to the issues in these challenges and not how to resolve them in future elections.)

Currently, the Office of the City Clerk - Election Division Policy No. 5 states that electioneering within 100 feet from the door of the polling place where voters cast their ballots is prohibited. This policy is posted at all polling places and the 100 feet area is marked and closely monitored outside the polling place during polling hours.

On Election Day, prior to the opening of the polls, Mr. Sigala approached the (Polling Place) Inspector, Sandra Mendoza, inquiring about the 100 feet "No Electioneering" perimeter markings and was shown by the Inspector the marked areas from all angles of the polling place entrance.

Mr. Sigala then stationed himself just a few feet beyond the 100 feet "No Electioneering" zone. The "No Electioneering" perimeter ended just a few feet short of the curb of the southeast corner of the polling place.

Mr. Sigala was stationed at the southeast corner from the opening of polls to the closing of polls. Every time the Inspector did a routine check outside the polls, Mr. Sigala was beyond the 100 feet "No Electioneering Beyond this Point" signage and postings.

The Inspector monitored all candidates promoting themselves and/or their slates to enforce the "No Electioneering" perimeter. The inspections occurred intermittently between 10 to 15 minutes apart. Two polling staff were assigned to monitor the marked "No Electioneering" perimeter for activity and to prevent Electioneering.

For the latter part of the polling hours, an additional polling place staff member was posted outside of the polling place to fully dedicate his attention to keeping the "No Electioneering Beyond this Point" area clear of any potential candidate activity.


Enforcement of the "No Electioneering Beyond this Point" perimeter was also confirmed by City Clerk staff member, Isaias Cantu, who was inspecting polling sites during the region-wide election.

RECOMMENDATION (Your recommendation as to how to ameliorate the issues that have been substantiated. No policy recommendations for future elections should be included in this section.)

The City Clerk recommends that the challenge be dismissed. Mr. Sigala and other candidates complied with the City Clerk - Election Division's Policy No. 5 of "No Electioneering", therefore no action is required and this challenge should be dismissed.

CHALLENGE (State the challenge and requested remedy verbatim - do not interpret or restate them.)

The challenge states that Erick Martell is not a homeowner, but a renter. The suggested remedy is that the City Clerk-Election Division invalidate Mr. Martell's qualifications to run and hold this seat.

FINDINGS (Based on your investigation, what you have been able to determine. Only speak to the issues in these challenges and not how to resolve them in future elections.)

Mr. Martell was an Area 1 - Resident Homeowner Representative candidate for the 2010 PUNC Board Member Election.

According to Article V, Section C of the PUNC Bylaws (Attachment A) and the Board Seat Description of the PUNC Election Procedures (Attachment B), candidates for the Resident Homeowner Representative seats must be stakeholders who are at least 18 years of age and own and occupy a residential property within the boundaries of the district seat for which they are running.

On January 19, 2010, Mr. Martell completed a Candidate Filing Form for the Area 1 - Resident Homeowner Representative for the 2010 PUNC Board Member Elections (Attachment C). Mr. Martell presented his California Driver's License, which listed 1739 South Catalina Street as his current address, to confirm his identity and residence. Mr. Martell also presented a copy of a grant deed for the property at 1739 South Catalina Street, which is located within Area 1 of the PUNC, to confirm his status as a homeowner. Mr. Martell is listed on the grant deed as a joint tenant in the property (Attachment D). In general, joint tenancy is a type of ownership of property by two or more people and a grant deed is a deed that is used to transfer ownership of property from one person to another. The grant deed proffered by Mr. Martell states that the property at 1739 South Catalina Street was to be legally transferred to him by his parents and was to be held in joint tenancy with three other family members.

However, on further investigation, it was determined that the deed that Mr. Martell provided to the City Clerk-Election Division was not signed or notarized at the time of filing. Mr. Martell was notified of this and was given the opportunity to provide the City Clerk-Election Division with supplemental documentation confirming he was the legitimate owner of the property at 1739 South Catalina Street at the time of candidate filing.

On April 29, 2010, Mr. Martell submitted a signed and notarized deed to the City Clerk-Election Division. However, the deed that Mr. Martell submitted was dated April 1, 2010, approximately 72 days after he filed for candidacy on January 19, 2010 (Attachment E). In order to qualify as a candidate for a NC board seat, a candidate must meet the board seat qualifications at the time of filing. The deed Mr. Martell provided on April 29 does not satisfy this requirement. Mr. Martell was once again notified and given the opportunity to provide the City Clerk-Election Division with supplemental documentation establishing that he was the legitimate owner of the property at 1739 South Catalina Street at the time of candidate filing.

On April 30, 2010 and again on May 3, 2010, Mr. Martell provided the City Clerk-Election Division a homeowner's insurance premium notice and policy (Attachment F). The premium notice and policy is addressed to Mr. Martell and several other presumed family members and was valid for a billing period between December 14, 2009 and December 14, 2011, which indicates that the policy was in place at the time of Mr. Martell's candidate filing. In general, possessing homeowner's insurance implies that the purchasers of the insurance had to provide the insurer proof of home ownership. However, since the policy does not *explicitly* prove that Mr. Martell is an owner of the property at 1739 South Catalina Street prior to April 1, 2010, coupled with the fact that Mr. Martell failed to produce a signed and notarized deed that was dated on or before January 19, 2010, the City Clerk-Election Division once again requested that Mr. Martell provide information to confirm his status as a homeowner at the time of candidate filing.

On May 4, 2010, Mr. Martell notified the City Clerk-Election Division that he wished to withdraw his candidacy from the 2010 PUNC Board Member Election due to unforeseen commitments and obligations (Attachment G). Mr. Martell submitted a Notice of Withdrawal to the City Clerk-Election Division on May 5, 2010 (Attachment H).

RECOMMENDATION (Your recommendation as to how to ameliorate the issues that have been substantiated. No policy recommendations for future elections should be included in this section.)

Since Mr. Martell withdrew his candidacy from 2010 PUNC Board Member Election before the City Clerk-Election Division could conclusively validate his status as a homeowner at the time he filed as a candidate, the City Clerk-Election Division recommends that Mr. Martell be formally disqualified and that the Area 1-Resident Homeowner Representative seat be awarded to the next highest vote getter, Sang Park. If Mr. Park does not accept this seat, then the City Clerk-Election Division

Neighborhood Council: Boyle Heights (BHNC)

CHALLENGE (State the challenge and requested remedy verbatim - do not interpret or restate them.)

"Manny" Aldana, Quadrant 4 At-Large The challenge states that "Manuel Representative is ineligible to run for a BHNC position based on Article IX - Section D-4 [sic] of the BHNC" and that "[Mr. Aldana] was removed from the previous BHNC board due to lack of attendance." The requested remedy is to remove Mr. Aldana as a candidate of the 2010 BHNC Elections. (See Attachment A)

FINDINGS (Based on your investigation, what you have been able to determine. Only speak to the issues in these challenges and not how to resolve them in future elections.)

On March 1, 2010, Mr. Aldana filed for the BHNC Quadrant 4 At-Large Seat in accordance with Article IX of the 2010 BHNC Election Procedures (see Attachment B). Prior to Mr. Aldana's filing, the challenger, Margarita Amador notified the BHNC Project Coordinator, Christopher Garcia, that Mr. Aldana had been removed from the BHNC board and was therefore ineligible to run for a seat on the BHNC (see Attachment C). In response, Mr. Garcia advised Ms. Amador that all challenges to a candidate's qualifications were to be made after the election and that all documentation supporting this claim was to be provided with the challenge (see Attachment C).

According to the BHNC Bylaws*, Article IX, Section D, subsection 4 "[i]f an Officer fails to consistently attend those meetings at which they are expected, the Executive Board shall remove the Officer and declare the seat vacant. Executive Officers are expected to attend all Executive Committee meeting, Board of Officers meetings and BHNC Board Members are expected to attend all Board of Officers General meetings. meetings and BHNC General meetings. Absence from four (4) consecutive meetings or seven (7) or more meetings during the previous twelve months shall be deemed a failure to consistently attend." (See Attachment D) According to Article IX, Section D, subsection 5 of the BHNC Bylaws, "[a] person removed from the Board is ineligible to serve on the Board for twelve (12) months from the date of removal."

According to attendance sheets submitted with this challenge, Mr. Aldana failed to attend at least eight (8) General Board Meetings held between August 26, 2008 and May 27, 2009 (see Attachment A). On May 28, 2009, Mr. Aldana was sent a letter from the BHNC Secretary and challenger, Ms. Amador, offering Mr. Aldana the opportunity to resign from his seat on the BHNC board before the board acted on the aforementioned bylaw clause regarding attendance (see Attachment A). On March 4, 2010, in response to an apparent grievance filed by Mr. Aldana with the BHNC on this matter, the BHNC Grievance Committee found that the BHNC exercised Article IX, Section D of the BHNC bylaws based on Mr. Aldana's lack of attendance and participation (see Attachment A).

Although the challenger has provided evidence that Mr. Aldana was notified that he was to be removed from the board if he did not voluntarily resign and that a grievance was processed by the BHNC on this matter, it is unknown to the City Clerk exactly when Mr. Aldana was removed from the Quadrant 4 At-Large Representative Seat by the BHNC and when the 12 month bar on serving on the board was set to begin and end. Furthermore, research of the available BHNC board meeting agendas and minutes fails to indicate when this issue was taken up and resolved by the BHNC board (see Attachment E).

During this investigation, the City Clerk had contacted Ms. Amador on several occasions and requested additional documentation establishing exactly when Mr. Aldana was removed from the BHNC board and what the 12 month bar on service was expected to be (see Attachment F). This information is crucial to substantiating Ms. Amador's claim as it is uncertain whether the 12 month bar on service has lapsed or not. To date, the requested information has not been provided by the challenger.

* Please note that the challenger submitted this challenge based on BHNC bylaws amended August 26, 2009. For the 2010 BHNC Elections, the City Clerk-Election Division has referred to the BHNC bylaws dated April 1, 2008. According to City Clerk-Election Division Policy: No. 10, all bylaws to be used for the 2010 NC Board Member Elections were to be submitted to the City Clerk-Election Division by June 1, 2009. Any revisions or amendments to bylaws made after this date were not to be applied retroactively. In this instance, there is no substantive difference between the two versions of the bylaws. However, for the sake of consistency, this report will refer solely to the BHNC bylaws dated April 1, 2008.

RECOMMENDATION (Your recommendation as to how to ameliorate the issues that have been substantiated. No policy recommendations for future elections should be included in this section.)

All challengers are required to submit all documentation and other evidentiary support to substantiate their claim(s). Since Ms. Amador has not been able to provide additional documentation or other evidence to further the City Clerk's investigation, the City Clerk recommends that this challenged be dismissed.

CHALLENGE (State the challenge and requested remedy verbatim - do not interpret or restate them.)

- Mr. Frobisher claims Bradley, GPNC Area 1 Candidate, does not reside in Area 1.

The remedy sought by Mr. Frobisher (the Challenger) is Bradley's removal from the newly-elected board.

FINDINGS (Based on your investigation, what you have been able to determine. Only speak to the issues in these challenges and not how to resolve them in future elections.)

Upon review of the challenger's claim, the City Clerk determined that candidate Bradley filed for Area 1 Representative for the GPNC Board.

Pursuant to the "Qualifications to Run for the Seat" outlined in the 2010 GPNC Election Procedures (Exhibit A, Attachment B) and Article V Section 3(c) of the GPNC Bylaws (Exhibit B), the documentation provided by Bradley met the Area Representative qualifications of residing in the area of Glassell Park that he wished to represent.

The types of documentation provided to the City Clerk supporting Bradley's stakeholder status were his California Driver's License which confirmed identity, age, and address, and a copy of a utility bill from the Department of Water and Power which re-confirmed the name and address declared on his Candidate Filing Form (See Exhibit C).

The challenger, Brian Frobisher did not submit supporting documentation to refute the candidate's declared Area 1 status.

Additionally, it was confirmed through the City Clerk's Systems Division GIS mapping that the address declared by the candidate is within the GPNC Area 1 boundaries (Exhibits D, E and F).

RECOMMENDATION (Your recommendation as to how to ameliorate the issues that have been substantiated. No policy recommendations for future elections should be included in this section.)

The Office of the City Clerk recommends that the challenge be dismissed and that the candidate, Bradley, retain the GPNC Area 1 seat as the candidate met the candidacy eligibility requirements under the GPNC EPs and GPNC Bylaws.

Challenger: Dr. Richard Dyke

Neighborhood Council: Historic Highland Park NC (HHPNC)

CHALLENGE (State the challenge and requested remedy verbatim - do not interpret or restate them.)

Challenge:

The HHPNC Election Outreach Committee members (Committee), including the Chair, ran for offices while supervising election funds and having access to other election resources. The Committee violated HHPNC Bylaws which prohibits Committee members from being candidates. (The challenge category is "Electioneering by Candidates" but the actual complaint is "Candidate Eligibility" which is challengeable.)

Proposed Remedy: Redo election.

FINDINGS (Based on your investigation, what you have been able to determine. Only speak to the issues in these challenges and not how to resolve them in future elections.)

On May 6, 2010, Dr. Richard Dyke challenged the candidacy of the Election Outreach Committee (Committee) members, including the Chair. His challenge alleged that there was a long standing ban against members of the Election Outreach Committee members running for office.

As evidentiary support, Dr. Dyke provided a draft copy of the 2005 HHPNC Election Procedures which stated in Article II, Section 1(A):

"The Ad Hoc Elections Committee shall be composed of seven (7) stakeholders who are not applying as candidates to the Governing Board. The election committee's duties include but are not limited to creating and establishing the election procedures and designating date, time and location of the election" (See Attachment A).

Similar language is contained in Article VI, Section 3 of the 2006 HHPNC Bylaws (as submitted to the City Clerk by the Department of Neighborhood Empowerment [DONE]) which state the following regarding the formation of the Ad Hoc Elections Committee:

"The Ad Hoc Elections Committee will be formed and meet only in conjunction with an election in order to plan, implement and supervise the elections of the Board and its Officers and to tabulate the votes and announce the election results. It shall be comprised of 7 stakeholders, none of whom are running for any office" (See Attachment B).

Furthermore, Dr. Dyke listed seven points in support of his assertion that the Election Outreach Committee, specifically Richard Marquez, Chair of the Committee, had used Neighborhood Council resources to advocate for specific candidates for the NC in addition to themselves and sway support to vote for his slate.

- 1. Mr. Marquez was responsible for overseeing the \$6500 allocated by the HHPNC Board for the hiring of an elections consultant.
- 2. The Chair of the Elections Outreach Committee, Mr. Marquez, supervised the internet website for the HHPNC (including the dissemination of eblast bulletins and email addresses).
- 3. Mr. Marquez and Teresa Bonsell ran for office and won, but should have known that they were restricted from doing so because of their participation on the Elections Outreach Committee.
- 4. Mr. Marquez, with the assistance of the Reform Agenda Committee, deliberately kept the HHPNC Board from considering the DONE request to develop an election outreach strategy and timeline.
- 5. A slate voter guide with two members of the Elections Outreach Committee was distributed.
- 6. An eblast/enewsletter was sent out on Election Day that encouraged its audience to get out and vote.
- 7. The Elections Outreach Committee did not adhere to the Brown Act.

The documents submitted by Dr. Dyke did not provide substantial evidence of wrong-doing done by Mr. Marquez, Ms. Bonsell or the members of the Reform Agenda Committee. Nevertheless, whether the seven issues are valid or not has no bearing on the issue being considered as a part of this challenge. The issue is whether the language in Article VI Section 3 of the Bylaws precludes membership of candidates on the committee or whether membership on the committee precludes a stakeholder from being a candidate.

The restriction in Article VI, Section 3 of the 2006 HHPNC Bylaws establishes that the Ad Hoc Election Committee shall be formed of non-candidates:

"It [Ad Hoc Elections Committee] shall be comprised of 7 stakeholders, none of whom are running for any office" (See Attachment B).

The formation is further supported by Article IV Section 10 that refers to the Ad Hoc Elections Committee:

"The Ad Hoc Elections Committee must be formed in accordance with Article VI, Section 3 of these bylaws within a reasonable and realistic timeframe in order to oversee and conduct the elections effectively" (See Attachment B).

Neither of these two clauses create any restrictions for being a candidate. Rather, they restrict participation on the Ad Hoc Elections Committee. It was the responsibility of the HHPNC Board to enforce their bylaws specific to the Ad Hoc Elections Committee membership. Pursuant to the bylaws, the HHPNC Board should have asked its Chair to step down or removed them from the Ad Hoc Elections Committee. This was an internal process established by the HHPNC. These are responsibilities of the HHPNC Board and not processes established by the City Clerk.

If the HHPNC Board wanted to add this condition to the candidacy eligibility requirements, they should have added the restriction to the candidate qualification requirements in their Bylaws. Alternatively, they could have notified the City Clerk during our meetings with them to discuss and prepare their Election Procedures. As the City Clerk received no such notification, the "Qualifications to Run for a Seat" on Attachment B of the 2010 HHPNC EPs only state:

"Stakeholders who live, work, own property or declare a stake in the neighborhood and affirm the factual basis for it and who are 18 years or older" (See Attachment C)

This definition is what was used to qualify the Ad Hoc Elections Committee members, including the Chair, for candidacy in the 2010 HHPNC Elections.

The 2006 Bylaws were created when the Ad Hoc Elections Committee was responsible for conducting the HHPNC Election. The 2010 HHPNC Election was conducted by the City Clerk and the Election Outreach Committee was established as an Ad Hoc Committee to focus on election outreach activities. More importantly, the current 2009 HHPNC Bylaws has no restrictions for any of the members of its committees to run for office (see Attachment D) as the administration and implementation of the election is under the City Clerk's purview.

RECOMMENDATION (Your recommendation as to how to ameliorate the issues that have been substantiated. No policy recommendations for future elections should be included in this section.)

The Office of the City Clerk recommends that the challenge be dismissed as the named candidates did not violate 2010 HHPNC Election Procedures.

Challenge:

The Challengers, Manual Campito, Coach Ron, Ronald Walker, Bobby May and Theodore Neubauer, all claim Mr. Gerald Phillips, Social Service Provider Director candidate, was ineligible at the time of the DLANC Election due to Mr. Phillips' "having given notice to his employer".

Proposed Remedy:

The Challengers seek an immediate investigation and declaration of the other three candidates in this race as winners of the three open Social Service Provider Director seats.

FINDINGS (Based on your investigation, what you have been able to determine. Only speak to the issues in these challenges and not how to resolve them in future elections.)

Upon review of the Challenger's claim, the City Clerk determined that candidate Mr. Gerald Phillips filed for Social Service Provider Director for the DLANC Board.

Pursuant to the "Qualifications to Run for the Seat" outlined in Attachment B of the 2010 DLANC Election Procedures (see Attachment A) and Article IV Section 4.01 and Article VI Section 6.01 of the DLANC Bylaws (see Attachment B), the documentation provided by Mr. Phillips met the Social Service Providers Directors stakeholder eligibility requirements.

The types of documentation provided to the City Clerk supporting Mr. Phillips stakeholder status were his California Driver's License (see Attachment C), a business card and a letter from his employer (see Attachment D). These documents establish Mr.

Phillips' identity and age (CA Driver's License) and employment for a Social Service advocacy group (letter from his employer) with an address within the DLANC boundaries as declared on his Candidate Filing Form (see Attachment E).

The Challengers, Mr. Campito, Coach Ron, Mr. Walker, Mr. May and Mr. Neubauer, did not submit any supporting documentation or evidence to refute the candidate's declared Social Service Provider Director status.

RECOMMENDATION (Your recommendation as to how to ameliorate the issues that have been substantiated. No policy recommendations for future elections should be included in this section.)

The Office of the City Clerk recommends that the challenge be dismissed and that the candidate, Mr. Phillips, retain the Social Service Provider Director seat as the candidate met the candidacy eligibility requirements and provided supporting documentation in accordance with the DLANC Election Procedures.

2010 WESTWOOD NEIGHBORHOOD COUNCIL (WWNC) - FINAL ELECTION CHALLENGE RESULTS

Dear Westwood Neighborhood Council Transition Committee,

On July 13, 2010, the Office of the City Clerk - Election Division (City Clerk) received an Election Challenge Application from Roxane Pearl Stern for the WWNC Election. After initial review, the City Clerk determined that the challenge submitted alleging electioneering by "Team Westwood" was challengeable under City Clerk - Election Division Policy No. 29.

After investigating the matter, the City Clerk compiled a report including a recommendation that the challenge be dismissed, as all electioneering was dealt with on Election Day. The full report was reviewed by a Neighborhood Council Election Challenge Review Panel (the Panel) (see attached). The Panel, composed of two Neighborhood Council stakeholders and one City Commissioner, was tasked with making the final ruling on this Election Challenge. The Panel, subsequently, ruled against the City Clerk's recommendation. The Panel deemed that "Team Westwood" violated the WWNC Election Procedures and policies set by the City Clerk and voted unanimously to approve the challenge, to disqualify the entire slate of candidates from "Team Westwood" that won seats in the election, and to award those seats instead to the next highest vote getters.

City Clerk - Election Division Policy No. 29 states that "[i]n order to preserve the integrity of the Neighborhood Council election process and ensure that the challenge process is fair, the City Clerk's Office, in its discretion, may issue a new determination and set aside the Review Panel's decision when there are either (1) insufficient facts supporting the Review Panel's decision or (2) the uncontroverted facts fail to demonstrate a violation of the spirit and intent of a specific election procedure."

In this case, after a review of the specific challenges and supporting evidence submitted by the challenger, when reviewed along with the testimony of polling place staff at the WWNC Election and the policies currently in place concerning campaigning and electioneering, the City Clerk found that there were insufficient facts to support disqualifying the "Team Westwood" slate and that the uncontroverted facts that were available equally to the Review Panel and the City Clerk-Election Division didn't demonstrate a violation of the WWNC Election Procedures.

After much intense and careful deliberation, the City Clerk concluded that the Panel's decision is not consistent with the guidelines set forth in City Clerk - Election Division Policy No. 29. The City Clerk will therefore exercise its authority permitted in Policy No. 29 to set aside the Panel's decision and dismiss the challenge. The City Clerk's decision is considered final. Additionally, the City Clerk will notify Ms. Stern of the City Clerk's decision. All Election Challenges for WWNC have been resolved. Accordingly, the NC is now free to seat the newly-elected board in accordance with City Clerk - Election Division Policy No. 22. The challenge, along with the City Clerk's recommendation and the Panel's final decision, will be posted on our website by Thursday, September 2, 2010.

The City Clerk sincerely understands and appreciates the concerns about aggressive campaign tactics and the dangers of electioneering. Under the current NC election policies and procedures, activity utilized by the "Team Westwood" candidate slate and other candidates and candidate groups across all NCs throughout the City are not improper. As previously mentioned, the City Clerk is open to addressing these and other concerns for the future conduct of NC elections.

CHALLENGE (State the challenge and requested remedy verbatim - do not interpret or restate them.)

Challenge:

Observed two women wearing "Team Westwood" t-shirts in the corridor; next to each verifying Clerk there was a sheet of addresses for various businesses that was also provided to Team Westwood for self-affirming voters, electioneering by the Curbside voting location, Team Westwood signs in corridor, Team Westwood flyer left on the table where Clerks were stationed.

Proposed Remedy:

Decertify election results. Hold a new Election

FINDINGS (Based on your investigation, what you have been able to determine. Only speak to the issues in these challenges and not how to resolve them in future elections.)

The Office of the City Clerk accepted a list of shopping areas and addresses within the Westwood boundaries in the event that a voting stakeholder needed assistance with writing the stores' address in their Stakeholder Registration Form. The list was with the Registration Clerks at all times. In the event that a stakeholder wrote the name of a store with no address, the Registration Clerks would refer to the list of stores in order to find the exact address and ensure that the location fell within the boundaries. All locations were pinpointed using maps developed by the City Clerk. No voting stakeholder was presented this document when filling out their registration form. The list of addresses was simply used as a tool to expedite the registration process in the event that a stakeholder could not recall cross streets or exact addresses for locations included on their Stakeholder Registration Form.

The Office of the City Clerk - Election Division anticipated a high turnout for Westwood Neighborhood Council's first election. The 62 candidates who were running for 19 seats

formed several slates and turned out to promote their candidacy throughout the day. City Clerk staff established a "no electioneering beyond this point" perimeter by placing signs 100 feet from the door to the room in the Westwood Recreation Center where voting took place. All slates were informed that they needed to stay outside the 100 feet perimeter in accordance with City Clerk - Election Division Policy Number 5 (see Attachment A). Election Division staff continuously monitored the area to ensure that no voter was approached once inside the 100 feet.

Throughout the day, several voters carried small leaflets containing candidate's names and used these as voting guides once they were at the voting booths. Election staff periodically inspected all registration tables, voting booths and the general area in the polling place. Election staff disposed of the leaflets left behind by voters in the facility throughout the day.

Two individuals came in to vote while wearing Team Westwood t-shirts and both were asked to take off their shirt or flip it inside out. Upon being advised by the City Clerk personnel, both individuals complied. Election staff then went outside and approached the area where Team Westwood was stationed and informed them that anyone wearing a Team Westwood shirt would be asked to turn it inside out when they entered to vote. The Team Westwood slate agreed that the shirt could be perceived as a form of electioneering and complied with our instruction for the remainder of the day.

According to Policy Number 5 (Attachment A), "100 feet is measured from the door of the polling place," which was inside the Westwood Recreation Center. The Office of the City Clerk set-up a Curbside voting station outside of the recreation center by the parking area. Two City Clerk Representatives were always present to process voters and to assure that no member of a slate conversed with any curbside voter. While curbside stakeholders voted, no member of any slate solicited their vote or distributed any flyers urging them to vote for certain candidates. Campaigning outside of the 100 feet boundary is permissible during all Neighborhood Council Elections regardless of the perceived intrusion stakeholders may feel. Once voters entered the Westwood Recreation Center, they may not be approached by any member of any slate and election staff was present to assure this was the case.

RECOMMENDATION (Your recommendation as to how to ameliorate the issues that have been substantiated. No policy recommendations for future elections should be included in this section.)

The Office of the City Clerk recommends that the Panel dismiss this challenge as all electioneering was dealt with on Election Day. Further, the Challenger's proposed remedy is too severe for the perceived offense and no proof was provided that if true, these allegations would have changed the election outcome which had substantial victory margins. The offense and the disproportionate election results (Attachment B) far outweigh any change of outcome that would occur in a new election.
