The Los Angeles City Council will conduct a Public Hearing relative to an Ordinance amending Chapter VI, Article 4.4, Sections 64.70.01 and 64.72 of the Los Angeles Municipal Code (LAMC) to expand the applicability of the existing Standard Urban Stormwater Mitigation Plan (SUSMP) requirements by imposing rainwater Low Impact Development (LID) strategies on projects that require building permits; and amending Section 64.72.05 of Article 1 of Chapter IX of the LAMC to collect fees to recover Bureau of Sanitation costs of administering the provisions of this Ordinance.
