I HEREBY MOVE that Council ADOPT the following recommendations, SUBJECT TO THE APPROVAL OF THE MAYOR, with respect to EXEMPTION, COMMUNICATION FROM THE CITY ATTORNEY and ORDINANCE relative to amending various sections of the Los Angeles Municipal Code relating to joint living and work quarters on today's Council agenda (Item 25, CF 09-1845):
