COMMUNICATION FROM CHAIR, JOBS AND BUSINESS DEVELOPMENT COMMITTEE relative to the evaluation of the City's taxing system for radio and television broadcasting industries and the different taxing methods, including a maximum tax similar to the entertainment production cap.

Recommendations for Council action, pursuant to Motion (Garcetti - Krekorian):

- 1. INSTRUCT the Chief Legislative Analyst (CLA) and Chief Administrative Officer (CAO), with the assistance of the Office of Finance, to re-evaluate the City's taxing system for radio and television broadcasting industries and report back on different taxing methods, including a maximum tax similar to the entertainment production cap.
- INSTRUCT the CAO to work with the Office of Finance and report back to the Jobs and Business Development Committee relative to the establishment of a minimum tax and its impact on the entertainment cap.
- INSTRUCT the Office of Finance to report back to the Jobs and Business Development Committee relative to the consistency on agency fees, impact of a minimum tax for entertainment cap on the general fund, and impact on the general fund if extended to broadcasting.

Fiscal Impact Statement: Neither the CAO nor the CLA completed a financial analysis of this report.
