

The City Council previously authorized a contract (City Contract No. 115880) between the City and Mr. Curt Livesay for professional consulting services to the City Attorney on legal and administrative matters in the areas of criminal prosecution, civil liability, municipal and government law, and public law office management. The contract, which was approved by Council on August 14, 2009 (CF 09-1082), includes an option for the City Attorney to extend Mr. Livesay's contract for up to two extensions of one year each under the same terms and conditions. The City Attorney has found Mr. Livesay's services invaluable to the Office and has already executed a one year extension of the contract.

Funds are needed to pay for the second year of this contract for professional consulting services and the City Attorney has requested a transfer of funds from the Unappropriated Balance for this purpose.

I THEREFORE MOVE that, subject to the approval of the Mayor, \$204,000 be appropriated from the "Outside Council inc. Workers' Comp." line item in the Unappropriated Balance Fund No. 100-58 to the City Attorney Fund No. 100-12, Account No. 9301 (Outside Counsel) to pay for a second year extension of Contract No. 115880 between the City and Curt Livesay for professional consulting services to the City Attorney on legal and administrative matters in the areas of criminal prosecution, civil liability, municipal and government law, and public law office management.
