The San Fernando Valley Historical Society is frequently asked to approve wireless telecommunications facilities in the San Fernando Valley.

We want to add our name to the other councils and groups that have sought reform of Los Angeles' wireless ordinances and demand greater protection for residential neighborhoods. We are informed that over a year has transpired since the effort for reform and more safety has been requested, with no response. This is a problem that has exponentially increased and is not going away. Why the delay?

The San Fernando Valley Historical Society is vehemently AGAINST any and all cell towers. Not only do they look ugly, cell towers are always emitting harmful radiation. The acid-based batteries are extremely flammable; in case of earthquake or other disaster, these proliferating cell towers would become sites of incendiary mini-disasters. Furthermore, some of the medical problems that have been proven to be caused by the chronic electromagnetic-field exposure in the microwave range (or radiation emitted) by these towers include:
