Cell tower regulation is sorely needed. An L.A. city ordinance is needed to ban cell towers near (within 1500 feet) of schools, playgrounds, parks, hospitals and nursing homes. The health effects of long-term exposure to radiation from cell towers (i.e., non-thermal effects) needs further study since the FCC regulations do not take non-thermal effects into account. Children, the sick and the elderly are the most vulnerable. Cell phone companies should be made to sustain the burden of proof that cell towers are safe before placing them near places where children or the elderly spend significant time. All effected persons (including students and their parents) should be given advance notice of a proposed cell tower, not just the land owner and adjacent properties.
