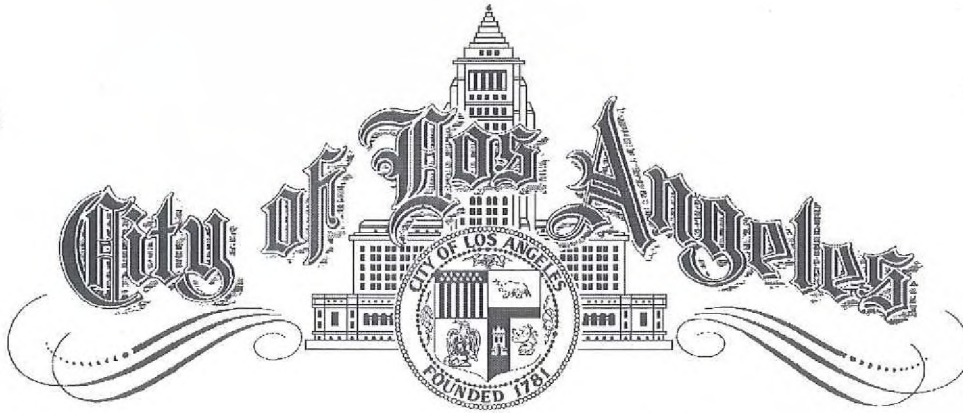


Honorable Members:

Pursuant to standing instructions from the City Council and the request of the Department of Transportation, this Office has prepared and transmits with this report, approved as to form and legality, a draft ordinance amending Los Angeles Municipal Code Section 80.81 to change the speed limit on portions of Chandler Boulevard in Council Districts 2, 4, and 5, to establish certain 40 and 45 miles per hour speed limits, in order to ensure radar enforcement. We sent a copy of this draft ordinance to the Los Angeles Police Department, which recommended adoption, as well as to the affected Council Offices, pursuant to City Council Rule 38. The draft was approved by the Board of Transportation Commissioners on September 24, 2009.

**ORDINANCE NO. \_\_\_\_\_**

An ordinance amending Section 80.81 of the Los Angeles Municipal Code to change the speed limit on Chandler Boulevard in the City of Los Angeles.

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**

Section 1. Subdivision C of Subsection (2) of Section 80.81 of the Los Angeles Municipal Code is amended by deleting the following:

On Chandler Boulevard between the westerly line of Lankershim Boulevard and easterly line of Van Nuys Boulevard.

Sec. 2. Subdivision C of Subsection (2) of Section 80.81 of the Los Angeles Municipal Code is amended by adding the following in alphabetical order:

Chandler Boulevard between Coldwater Canyon Avenue and Van Nuys Boulevard.

Sec. 3. Subdivision C of Subsection (3) of Section 80.81 of the Los Angeles Municipal Code is amended by adding the following in alphabetical order:

Chandler Boulevard between Lankershim Boulevard and Vineland Avenue.

Sec. 4. Subdivision C of Subsection (4) of Section 80.81 of the Los Angeles Municipal Code is amended by adding the following in alphabetical order:

Chandler Boulevard between Coldwater Canyon Avenue and Lankershim Boulevard.

Sec. 5. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.


