On June 29, 2010, the City Council passed a revised Oversize Vehicle Ordinance (CF 09-3036, Ordinance No. 181218). As detailed in this Ordinance, Council may establish an area prohibiting the overnight parking of oversize vehicles.

Venice Beach is a residential area consisting of single and multi-family homes with inadequate parking. This is a problem exacerbated by the parking of oversized vehicles resulting in the inability of residents to find parking on their blocks as well as other issues adversely impacting their quality of life.

Residents of Venice Beach are in the process of circulating petitions requesting establishments of a restricted oversized vehicle parking area, and will soon present these petitions to the Councilmember of the 11<sup>th</sup> District. Additionally, LADOT shall work with the Council District in order to respond to requests from the Councilmember relative to sign installation without petition on streets where there is no business or residential frontage.

I THEREFORE MOVE that the City Attorney, with assistance of the Department of Transportation, be requested to prepare and present an urgency ordinance that prohibits or limits the parking of oversize vehicles on certain streets in the Venice area between 2:00 A.M. and 6:00A.M. as follows: the area bounded on the east by Lincoln Blvd., the area bounded on the south by the Los Angeles County line, the area bounded on the west by Ocean Front Walk and the area bounded by the border with the City of Santa Monica on the north.

I FURTHER MOVE that \$35,000 be transferred from the Venice Area Surplus Property Fund No. 434, Dept. 50 to the Department of Transportation Fund No. 100, Dept. 94, Account No. 1090 (Salaries Overtime ) for the staff time associated with fabrication and installation of these oversize vehicle parking signs.

I FURTHER MOVE that \$15,000 be transferred from the Venice Area Surplus Property Fund No. 434, Dept. 50 to the Department of Transportation Fund No. 100-94, Account No. 3350 (Paint & Sign Maint. & Repairs) for the fabrication and installation of these signs.


I FURTHER MOVE that the Department of Transportation be authorized to deem those residents of Walk Streets to be residents of the nearest adjacent street segment for purposes of allowing residents to purchase oversize vehicle parking permits pursuant to the provisions of Subsection (c) of Section 80.69.4 of the Los Angeles Municipal Code.


