We declare that on September 2, 2014, a Brown Act noticed public meeting was held by the Eagle Rock Neighborhood Council (ERNC) at which a quorum was present, and the following motion was passed (14 yes, 1 no):

Resolved, the ERNC recommends that the City Council, Planning Department, and City Attorney amend the Colorado Boulevard Specific Plan to strike item 6. B. h., the prohibition of businesses operating between 9:00pm and 7:00am. The rest of the Prohibited Use section shall remain intact.
