The City Council held a Closed Session on Wednesday, March 17, 2010, pursuant to authority provided in California Government Code Section 54956.9(a), to confer with its legal counsel relative to the case entitled Michael Rodgers v. City of Los Angeles, et al., Los Angeles Superior Court Case No. SC 103002. (This case arises out of a personal injury claim against the City involving a plaintiff being struck by a golf ball at a City of Los Angeles golf course; Budget and Finance Committee considered the above matter on March 1, 2010).

VERBAL MOTION

I HEREBY MOVE that Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled Michael Rodgers v. City of Los Angeles, et al., Los Angeles Superior Court Case No. SC 103002. (This case arises out of a personal injury claim against the City involving a plaintiff being struck by a golf ball at a City of Los Angeles golf course.), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. **AUTHORIZE** the City Attorney to expend \$150,000 in settlement of the case entitled Michael Rodgers v. City of Los Angeles, et al., Los Angeles Superior Court Case No. SC 103002, from the Liability Claims Account No. 9770, Fund 100, Department 59.
2. **AUTHORIZE** the City Attorney to draw a demand thereon in said amount payable to the Law Offices of Aaron s. Bregman and Michael Rodgers.
3. **AUTHORIZE** the City Attorney, or designee, to prepare Controller instructions, for any necessary technical adjustments, subject to the approval of the City Administrative Officer, and **AUTHORIZE** the Controller to implement the instructions.

This matter was approved by the Budget and Finance Committee (Parks-Huizar-Rosendahl-Smith "yes") at its meeting on March 1, 2010, in Closed Session as permitted by Government Code Section 54956.9(a).
