SUBJECT: RESOLUTION NO. 15-7792 - FIRST AMENDMENT TO AGREEMENT NO. 09-2818 BETWEEN THE CITY OF LOS ANGELES HARBOR DEPARTMENT, TRAPAC APPELLANTS AND SOUTH COAST AIR QUALITY MANAGEMENT DISTRICT TO INSTALL AIR FILTRATION SYSTEMS IN LOCAL SCHOOLS

Pursuant to Section 373 of the City Charter and Section 10.5(a) of the Los Angeles Administration Code, enclosed for your approval are Resolution No. 15-7792 and First Amendment Agreement No. 15-2818-A between the City of Los Angeles Harbor Department, TraPac Apellants and South Coast Air Quality Management District to install air filtration systems in local schools, which were approved at the April 23, 2015 meeting of the Board of Harbor Commissioners. There is no impact to the General Fund.

- 3. Return to the Board of Harbor Commissioners for further processing.
