

Dear Councilmembers:

We represent Waste Management, which is seeking to develop a state-of-the-art, LEED Gold-certified material recycling facility, transfer station, and expanded green and wood waste recycling facility at its Sun Valley Recycling Park site, which is the location of the now-closed Bradley landfill (the "Project"). We have attached a survey of other permitted green waste facilities in the City that we inadvertently did not attach to our May 3, 2010 letter to the PLUM Committee. This study, which was based on site visits and a review of aerial photos by qualified Waste Management personnel, shows that none of the other facilities are covered or enclosed or have state-of-the-art odor control systems like Waste Management's facility.
