PUBLIC SAFETY COMMITTEE REPORT relative to proposed Animal Services Fees for Fiscal Year (FY) 2010-11.

Recommendation for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

APPROVE the FY 2010-11 Animal Services Fees schedule (attached to the Council file) proposed by the Department of Animal Services, and AUTHORIZE the Department of Animal Services to implement the new fee schedule effective July 1, 2010.

Fiscal Impact Statement: The CAO reports that the proposed fee schedule is estimated to generate an additional \$250,000 in revenue for the General Fund. This action is in compliance with City financial policies in that the proposed fee is estimated to fully recover the costs of providing the associated services.

Community Impact Statement Submitted: None

SUMMARY

In a report to Council dated June 2, 2010 (attached to the Council file), the CAO recommends approval of the FY 2010-11 Animal Services Fees schedule proposed by the Department of Animal Services. 
