

**report as follows:**

ARTS, PARKS, HEALTH, AND AGING COMMITTEE REPORT and COMMUNICATION FROM CHAIR and MEMBER, HOUSING, COMMUNITY, AND ECONOMIC DEVELOPMENT, and ORDINANCE relative to the elimination of the Human Services Department (HSD) and transfer of the Human Relations Commission (HRC) and the Commission on the Status of Women (CSW) to the Community Development Department (CDD).

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. ADOPT the accompanying Ordinance transferring the HRC and CSW to the CDD with the following technical correction: Page three of the Ordinance, Section (d), Terms of Board Membership, the second sentence should read: "The Mayor shall initially appoint three members to terms that end June 30, 2012, and four members to terms that end June 30, 2014."
2. RESCIND the 2009-2010 Departmental Personnel Ordinance for the HSD, Ordinance No. 180964, effective June 30, 2010.
3. AUTHORIZE the City Administrative Officer (CAO), Controller, CDD, Personnel Department, and other relevant departments to implement actions needed to eliminate the HSD and transfer the functions of the HRC and CSW to the CDD, and report back within 45 days relative to the status of these actions.

Fiscal Impact Statement: The Mayor reports that the CAO projects that the transfer of the HRC and CSW functions to the CDD will result in \$2 million in savings to the General Fund. Savings were calculated based on staff salaries and full related cost. Ongoing administrative support for the HRC and CSW will be funded through the Community Development Block Grant (CDBG).

Community Impact Statement: None submitted.

**Time Limit File – June 12, 2010  
(Last Day for Council Action – June 11, 2010)**

Summary:

In his report dated April 23, 2010, the Mayor recommends that Council approve the recommendations listed above relative to the elimination of the HSD and transfer of the HRC and CSW to the CDD. The Mayor reports that on March 2, 2010, Council approved his proposal to eliminate the HSD with an understanding that certain key services and functions of this department would be transferred to the CDD. Specifically, the Mayor proposed that the work performed by the members of the HRC and the CSW now be supported by the CDD. The Mayor asked that all efforts be made to reassign HSD personnel to non-General Funded positions, where deemed in the best interest of the City. The Mayor, by exercising his authority under Section 514 of the Los Angeles City Charter, transmitted for Council's consideration the accompanying Ordinance effectuating these changes.

The Mayor further reports that the HRC and CSW will provide policy advice to his Office, Council, and the CDD on a range of issues of importance to the City, including immigrant integration, race relations, and the interests and concerns of women. After adoption of the Ordinance, the Mayor will forward his list of Commissioner appointments. The Mayor notes that it is his present intention to first select appointees from among existing active members of the HRC and CSW. The HRC and CSW will be staffed by the CDD with a Senior Management Analyst and a Management Analyst II, respectively. All HRC and CSW positions will be funded through the CDBG.

At its regular meeting held May 19, 2010, the Housing, Community, and Economic Development Committee Chair and Member considered this matter and recommended that Council approve the recommendations of the Mayor, as submitted in his report dated April 23, 2010, and with the following technical correction: Page three of the Ordinance, Section (d), Terms of Board Membership, the second sentence should read: "The Mayor shall initially appoint three members to terms that end June 30, 2012, and four members to terms that end June 30, 2014."

On May 25, 2010, the Arts, Parks, Health, and Aging Committee considered this matter and concurred with the recommendations of the Housing, Community, and Economic Development Committee Chair and Member.
