RE: CF 10-0982 ANIMAL-LIMIT INCREASE IN THE CITY OF LOS ANGELES



IMPORTANT ALERT: MISLEADING E-MAIL FROM ED MUZIKA RE PHYLLIS DAUGHERTY

I have confirmed that on August 13, 2010 at 4:56 PM, an e-mail was sent to you from Ed Muzika (edwardmuzika@sbcglobal.net) with the Subject: "Phyllis Daugherty Responds to My Rebuttal of Her Protest on Increasing Pet Limits, With My Response."

This is to advise you that I, Phyllis Daugherty, did not write the almost unintelligible wording contained in that alleged e-mail (in which I purportedly misspelled my own name as DAUGERTY in this false posting) to a Mr. Edward Muzika regarding animal limits in the City of Los Angeles.

Although I continue to fully support our position of maintaining the current three (3) animal (cat/dog) limits in the City of Los Angeles, I have had absolutely no communication with Mr. Muzika, and I had no knowledge of this alleged communication in my name presented to you by Mr. Muzika, falsely alleging that he received it from me. I have seen the content as a result of a Public Information Request.

My legal counsel is addressing this issue on my behalf with Mr. Muzika. We have demanded an immediate retraction.

I apologize that there has been an apparent attempt to misrepresent that posting as coming from me by Mr. Muzika and to taint my credibility with members of the City Council and the Commission and Department of Los Angeles Animal Services, and I ask you to disregard his communication.
