Re: Reappropriation of Funds for Fiscal Year 2012-13 for the Urban Areas Security Initiative (UASI) Grant Programs 2010 (Council File No. 10-1166) and 2011 (Council File No. 11-1256)

Dear Honorable Members:

Transmitted herewith for City Council consideration is approval for the reappropriation of funds for Fiscal Year 2012-13 for the Urban Areas Security Initiative (UASI) grant 2010 and 2011 awards from the United States Department of Homeland Security (DHS). The UASI projects outlined in the report were approved previously and the request is to continue to fund these projects until the grant deadline.

## UASI 10 (Council File No. 10-1166)

On July 19, 2011, City Council accepted the FY10 UASI award in the amount of \$55,937,717 for a performance period of October 28, 2010 to April 30, 2013.

For various FY10 UASI projects, funds were appropriated to the Los Angeles Police, Fire and Emergency Management Departments, and Information Technology Agency. A total of \$2,034,620.57 is being requested to be appropriated to the Los Angeles Police, Fire, Emergency Management Departments, and Information Technology Agency for approved FY10 UASI projects as referenced in Attachment 1. All positions authorities for the LAFD and EMD were included in the Personnel Authority Resolution (PAR) (Council File No. 12-1700). The grant funded positions are partially funded through the FY10 UASI grant and will continue to be funded from other Homeland Security grants including FY11 and FY12 UASI, or the FY09 and FY10 Regional Catastrophic Planning Grant Program (RCPGP).

The federal grant guidelines allows up to 5% of the UASI grant for salary and fringe benefit costs for grant and financial management staff. As the administrator and fiscal agent of the UASI grant, the Mayor's Office funds grant and financial staff with the allowable 5% of management and administration (M&A) funds. A portion of the FY10 UASI M&A funds will

fund one dedicated City Attorney whose responsibilities include drafting, approving, and executing all contracts associated with this grant. The City Attorney salary costs will continue to be covered by other Homeland Security and Public Safety grants including FY11 UASI and the FY12 Justice Assistance Grant (Council File No. 09-0648-S5) for the remainder of the FY2012-13 and subsequent fiscal years. In addition to the City Attorney salary costs, the Mayor's Office is requesting to appropriate funds for the grant and financial management staff salaries and fringe benefit costs. The total amount being appropriated for management and administration funds is \$861,831.96.

## UASI 11 (Council File No. 11-1256)

On June 6, 2012, City Council accepted the FY11 UASI award in the amount of \$58,035,381 for a performance period of November 18, 2011 to April 30, 2014.

A total of \$2,471,439.90 is being requested to be appropriated to the Los Angeles Police, Fire, and Emergency Management Departments for approved FY11 UASI projects as referenced in Attachment 1. All positions authorities for the LAFD and EMD were included in the Personnel Authority Resolution (PAR) (Council File No. 12-1700). The grant funded positions are partially funded through the FY10 UASI grant and will continue to be funded from other Homeland Security grants including FY11 and FY12 UASI, or the FY09 and FY10 Regional Catastrophic Planning Grant Program (RCPGP).

As stated previously, the federal grant guidelines allows up to 5% of the UASI grant for salary and fringe benefit costs for grant and financial management staff. As the administrator and fiscal agent of the UASI grant, the Mayor's Office funds grant and financial staff with the allowable 5% of management and administration funds. A portion of the FY11 UASI M&A funds will fund one dedicated City Attorney whose responsibilities include drafting, approving, and executing all contracts associated with this grant. The City Attorney salary costs will continue to be covered by other Homeland Security and Public Safety grants including FY10 UASI and the FY12 Justice Assistance Grant (Council File No. 09-0648-S5) for the remainder of the FY2012-13 and subsequent fiscal years. In addition to the City Attorney salary costs, the Mayor's Office is requesting to appropriate funds for the grant and financial management staff salaries and fringe benefit costs. The total amount being appropriated for management and administration funds is \$125,038.10.

#### RECOMMENDATIONS

It is therefore requested that the City Council:

- 1. Authorize the Controller to:
  - a. Transfer appropriations and create new appropriations accounts within Fund 53V, UASI 10 (Council File No. 10-1166), as follows:
