PEGGY HILL - PROFESSIONAL BACKGROUND

Peggy Hill brings an unmatched record of accomplishments as a successful affordable housing developer, property manager and advocate for low income families in Los Angeles. In her former role as Executive Director and President of FAME Housing Corporation from 1985 to 2007, Ms. Hill led one of the first nonprofit community development corporations in Los Angeles that successfully utilized low income housing tax credits to finance the development of rental housing for low and moderate income residents. She supervised the takeover and transfer of property management responsibilities for several hundred housing units from a private management company to FAME Housing, and she managed all aspects of occupancy, compliance, financial reporting and property maintenance. She also created and managed FAME Health Corporation which provides services to low income households including antitobacco campaigns and AIDS education and prevention.

Ms. Hill is currently an Independent Consultant, providing Asset Management and Relocation services to Non-Profit Developers and agencies providing services to low income communities across Los Angeles. From 1974 to 1984 at Merrill Lynch, Pierce, Fenner & Smith, Inc., Ms. Hill was a financial planner and developed and analyzed portfolios and monetary budgets for corporate and individual clients. As a financial record keeper/researcher she developed and maintained a system to record dividend and interest payments. She also compiled records & receipts for private and corporate accountants and attorneys for review in a variety of areas including finalizing tax reports, estate planning, trust accounts, foundation grants and nonprofit corporations and agencies.

Ms. Hill has given lectures on The Dow Jones Industrial Average Principles of Investments and Nonprofit Housing Development Principles of Development at a variety of organizations and institutions. Ms. Hill received her educational background from the following institutions: National Urban League Business Education, New York City, Borough of Manhattan Community College – Business Education, Santa Monica City College – Accounting / Business Education, Los Angeles City College – Accounting / Business Education, Donald Reagan School of Finance – Finance, Anthony Schools- Real Estate, Evelyn Wood Dynamics of Reading – Reading, Ludlow Time Management School – Time Management, AMI Securities – Church Bond Underwriting.
